I am, by direction, to inform that the students who are eligible for promotion to the III Semester of **Second Year LL.M. Degree Courses** during the Academic Year 2020-2021, are required to pay their Second Year Fee, prescribed as follows, to get admission to the Second Year in the Academic Year 2020-2021:

- The students who voluntarily pay their entire fee for the II Year in one lump sum shall be accepted.
- The students who express their inability to pay the entire fee in one lump sum are permitted to pay their fee in **two slots** without any penalty as mentioned above.

- **SC/ST students** are exempted from payment of Tuition Fee and required to pay the Special Fee Only.
- Students under the category "**Differently Abled Persons**" are exempted from payment of Tuition Fee and Special Fee. However, they are required to pay a sum of Rs.10 only as admission application fee.
- The eligible students are required to pay the above mentioned Fee in any of the Indian Bank, by way of the "**Academic Payment Challan**", available in the University Website: www.tndalu.ac.in, on or before the last dates as mentioned above.
