CIRCULAR

Notabene : Current office bearers and members of any other committee(s) are **not eligible** to apply for any of the abovementioned positions.

The Editorial Board shall consist of 35 members. A Core Committee comprising of the Editor-in-Chief, Executive & Managing Editors and Chief Designer shall be established.

The committee members, headed by the Editor-in-Chief shall be responsible for all operational and editorial aspects of the publication, with the active guidance of the Hon'ble Chief Patron, Hon'ble Patron and Faculty Advisors.

APPOINTMENT OF THE EDITORIAL BOARD

The selection procedure shall be fair and transparent. The appointment shall be made strictly on the basis of merit. The members shall be appointed by the concerned authorities from the short-listed applicants on the basis of his/her abilities and skill.

APPLICATION GUIDELINES

Interested students must submit the following through an e-mail:

- i. An **Application Letter** specifying the post(s) for which the applications submitted mentioning their full name, year and Programme of study and contact information of the applicants. If a person is applying for more than one post, then it shall be submitted as a single application only, mentioning all posts applied for in a single application letter. Multiple applications shall not be considered.
- ii. **Curriculum Vitae / Resume**, including details regarding
 - List of Publications
 - Editorial Experience/Writing Experience
 - Leadership Experience
 - Designing Experience / relevant computer skills, if applying for the post of designer(s)
- iii. A **Statement of Purpose** of not more than 500 words elucidating briefly the applicant's interest and motivation, including future contributions for the amelioration of the Committee.

The e-mails containing the application are to have "**Application for Lexcellence 2022-2023**" as the subject of the e-mail. The mail in the prescribed format shall be sent to lexcellence.tndalu@gmail.com on or before **11.59 p.m.** on **17th of October (Monday), 2022.**

Applications sent to any other e-mail id shall not be considered. The final list of selected candidates shall be published on the notice boards.
