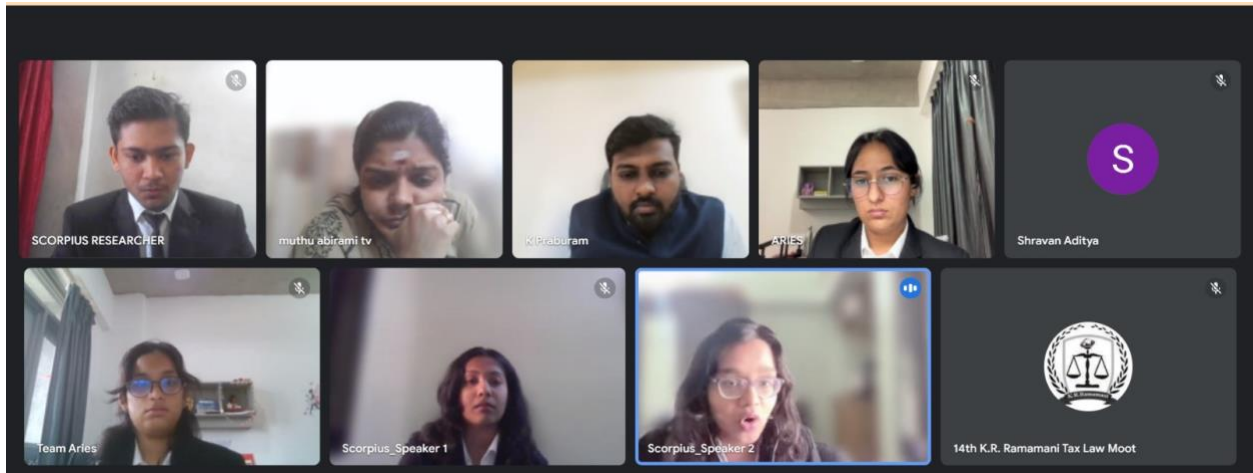


14th K.R.Ramamani Memorial National Taxation Moot Court Competition
