As per the plan of activities, the CECLJ has conducted a Consumer Awareness Cum Legal Aid Camp successfully in the Sivapuram village, Sriperumbudur Taluk, Kanchipuram District on 27.06.2019. It is creditworthy to note that the arrangements for the programme have been made by Thiru, Pichandi (former Councillor, Sivapuram village), an esteemed person in the locality. About 100 people in the village including women and children were in the programme.

Dr.Ranjith Oommen Abraham (Project Director) and V.Anandha Kumar (Research Associate) have briefed the rights, duties and remedies available to the consumers under the Consumer Protection Act, 1986. Haja Hassan (Assistant Professor, TNDALU) who acted as a resource person, had delivered some lightening thoughts on the remedies available to the consumers in the Consumer Courts. As a part of the programme, several pamphlets containing information regarding consumer awareness were distributed among the villagers, both in English and Tamil.
