



As the Tamil Nadu Dr.Ambedkar Law University has proposed to recruit Assistant Professor on contract basis, Guest faculties and non-teaching staff, there is a huge financial commitment to the University towards salary and allowances. Therefore, she has requested the Government to consider to sanction a sum of Rs.15,00,00,000/-(Rupees Fifteen crore only) as an adhoc grant for the year 2018-2019 in order to meet out the expected short fall expenditure towards payment of salary and allowances to the staff, amenities, Students facilities, repairs and maintenances, contribution towards pension and terminal benefits.

2. The Government, after careful consideration, have decided to sanction a sum of Rs. 7,00,00,000/- (Rupees Seven crore only) as grant for the year 2018-2019 in order to meet out the expected short fall expenditure towards payment of salary and allowances to the staff, amenities, students facilities, repairs and maintenances, contribution towards pension and terminal benefits to the Tamil Nadu Dr.Ambedkar Law University, Chennai.
