

#### ORDER:

The Finance Officer, Tamil Nadu Dr. Ambedkar Law University, Chennai, in her letter read above has furnished the expenditure for the current year 2019-2020, as follows:-

As such, she has requested the Government to sanction a sum of Rs.28,25,63,530/- (Rupees Twenty Eight Crores Twenty Five Lakhs Sixty Three Thousand Five Hundred and Thirty only) as Grant to meet out the current expenditure.

2. The Government, after careful consideration, have decided to restrict the claim of Registrar(i/c), Tamil Nadu Dr. Ambedkar Law University and hereby sanction a sum of Rs.1,00,00,000/-(Rupees One Crore only) towards Grants to meet out the current expenditure to the Tamil Nadu Dr. Ambedkar Law University, Chennai.

3 The expenditure sanctioned in para 2 above shall be debited to the following head of account:-

"2202.General Education – 03.University and Higher Education – 102. Assistance to Universities – State's Expenditure – AM. Law University, Chennai – 309. Grants-in-Aid – 01. Grants for Current Expenditure (DPC.2202-03-102-AM-30901(IFHRMS)) Old DPC – (2202-03-102-AM-0910)".

- 4. The expenditure sanctioned in para 2 above shall be met from the existing Budget provision available under the above head of account.
- 5. The Director of Legal Studies, Chennai, is authorized to draw and disburse the amount sanctioned in para 2 above to the Tamil Nadu Dr. Ambedkar Law University, Chennai.



#### **ABSTRACT**

The Tamil Nadu Dr. Ambedkar Law University – Official Committee for considering sanction of Block Grant reconstituted – Accepting the recommendations of the Official Committee and sanction of Block Grant - Orders – Issued.

#### ORDER:

In the G.O. 3<sup>rd</sup> read above, orders were issued reconstituting the Official Committee for the purpose of considering the sanction of Block Grant to the Tamil Nadu Dr.Ambedkar Law University, Chennai with the following members:-

(1) Secretary to Government, Law Department.

- (2) Principal Secretary to Government (Expenditure), Finance Department.
- (3) The Registrar (i/c), the Tamil Nadu Dr. Ambedkar Law University, Chennai.
- (4) Director of Legal Studies.
- (5) Director of Local Fund Audit.

2. In the letter 5<sup>th</sup> read above, the Director of Legal Studies has enclosed the Report of the Official Committee for fixing the Block Grant to the Tamil Nadu Dr.Ambedkar Law University for taking appropriate action by the Government. The details of the recommendations contained in the Report are as follows:-

The Committee, considering the fact that 84 out 116 teaching posts are vacant and that the University is currently in the process of intiating recruitment to fill up the said vacancies has recommended two Block Grants, namely Block Grant - I to be sanctioned before the recruitment process is complete and Block Grant - II for the period after completion of the recruitment. Accordingly, Block Grant - I (for current posts) and Block Grant - II (for posts including proposed Recruitment) have been prepared and estimated in annexure I & II of the Report.

# RECOMMENDATIONS:

- (a) Block Grant I may be fixed at Rs.5.43 crores annually to be released for the year(2019-20)allowing recruitment is completed before March 31, 2020.
- (b) Block Grant II for the year 2020-21 onwards may be fixed at Rs.15.23 crores. However, if recruitment is not completed within 2019-20, only Block Grant-I shall be allowed for 2020-21.
- (c) The above recommendation will also incentivise the Law University to fill up the posts early to improve the quality of Education.
- (d) Posts sanctioned by the Syndicate without prior scrutiny by the Finance Committee shall attract penalty and shall not only result in disallowance of the expenditure on that account for any Grants but also shall result in penalty by reducing future grants.
- (e) If the University incurs excess expenditure due to wrong pay fixation, arbitrary higher scales of pay in violation of Government Orders, disallowance and/or penalty may be imposed and consequential deductions shall be effected in the Additional Grant.
- (f) However, in future, if the Distance Education Program is implemented, 80% of the actual receipt towards tuition fees (UG + PG) shall be taken along with 15% of the fee receipt of the Distance Education Program for fixing revised Block Grant.

3. The Government, after careful consideration, have decided to accept the aforesaid recommendations of the Official Committee and hereby orders as follows:-

(a) Block Grant-I will be fixed at Rs.5.43 crores annually to be released for the year (2019-2020) allowing recruitment is completed before March 31, 2020 to the Tamil Nadu Dr.Ambedkar Law University, Chennai.

(b) Block Grant-II for the year 2020-2021 onwards will be fixed at Rs.15.23 crores. However, if recruitment is not completed within 2019-2020, only Block Grant-I shall be allowed for 2020-2021.

Since Rs.1.00 crore have already been sanctioned to the Tamil Nadu Dr.Ambedkar Law University, Chennai, the Government hereby sanction the balance amount of Rs.4.43 crore as Block Grant-I for the year 2019-2020 to the Tamil Nadu Dr.Ambedkar Law University, Chennai.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

"2202.General Education - 03.University and Higher Education - 102. Assistance to Universities - State's Expenditure - AM. Law University, Chennai - 309. Grants-in-Aid - 01. Grants for Current Expenditure (DPC.2202-03-102-AM-30901(IFHRMS)) (Old DPC - 2202-03-102-AM-0910)".

5. Necessary additional funds will be provided in FMA 2019-2020. Pending provision of such funds, the Director of Legal Studies, Chennai is authorized to draw and disburse the amount sanctioned in Para 3 above. However, the above expenditure shall be brought to the notice of the Legislative Assembly by specific inclusion in the Supplementary Estimate. The Director of Legal Studies, Chennai is also requested to send necessary draft explanatory notes to the Government in Finance (Home-II) Department for the specific inclusion of the above expenditure in

time, without fail.

6. This order issues with the concurrence of Finance Department <u>vide</u> its U.O.No.3631/Home-II/2020, dated 03.02.2020 and with ASL No.2977 (Two Thousand Nine Hundred and Seventy Seven).
