

ABSTRACT

Law Department-The Tamil Nadu Dr.Ambedkar Law University - Sanction of Block Grant-1 - Released - Orders - Issued

1. G.O.(Ms) No.35, Law (LS) Department, dated 06.02.2020.

2. From the Registrar (i/c), the Tamil Nadu Dr. Ambedkar Law University, Letter C.No.814/Regr/Estt/A2/2021, dated 12.03.2021.

ORDER:

In the G.O. first read above, accepting the recommendations of the Official Committee constituted for the purpose of considering the sanction of Block Grant to the Tamil Nadu Dr.Ambedkar Law University, Chennai among others it has been ordered as follows:-

- (a) Block Grant-I will be fixed at Rs.5.43 crores annually to be released for the year (2019-2020) allowing recruitment is completed before March 31, 2020 to the Tamil Nadu Dr.Ambedkar Law University, Chennai.
- (b) Block Grant-II for the year 2020-2021 onwards will be fixed at Rs.15.23 crores. However, if recruitment is not completed within 2019-2020, only Block Grant-I shall be allowed for 2020-2021.
- 2. In the letter second read above, the Registrar (i/c), the Tamil Nadu Dr. Ambedkar Law University among others has stated that the University will take all immediate steps to complete the recruitment process at the earliest to comply with the condition stipulated for releasing Block Grant-II by the Government and has requested the Government to release Block Grant-I for the year 2020-2021.
- 3. The Government, after careful consideration of the request of the Registrar, have decided to release a sum of Rs.5,43,00,000/-(Rupees five Crore and forty three Lakhs only) as Block Grant-I for the year 2020-2021 to the Tamil Nadu Dr. Ambedkar Law University, Chennai, which has been sanctioned in the Government order read above.
- 4. The amount sanctioned and released in para 3 above shall be debited to the following head of account:-
 - "2202.General Education 03.University and Higher Education 102. Assistance to Universities State's Expenditure AM. The Tamil Nadu Dr.Ambedkar Law University, Chennai 309. Grants-in-Aid 01. Grants for Current Expenditure (DPC.2202-03-102-AM-30901(IFHRMS)) (Old DPC 2202-03-102-AM-0910)"

- 5 The aforesaid amount shall be met from the existing budget provision available in FMA 2020-2021 under the above head of account. The Director of Legal Studies, Chennai, is authorized to draw and disburse the amount sanctioned in para 3 above to the Tamil Nadu Dr Ambedkar Law University, Chennai.
- 6. This order issues with the concurrence of Finance Department <u>vide</u> its U.O. No.14844/Home-II/2021, dated 23.03.2021.
