Sub: The Tamil Nadu Dr.Ambedkar Law University, Chennai - Teaching Establishment - Movement of Teaching Staff to the Higher Cadre as per UGC/State Government norms under **Career Advancement Scheme - Revised Applications - Invited - Extension of Last Date** - Intimated - Reg.

Ref: Circular No.4011/Regr/Estt[T]/A2/2015, dated 09.10.2015.

It is informed that under reference cited, applications were invited from the Regular Teaching faculty members of the Tamil Nadu Dr.Ambedkar Law University, who are eligible for movement to higher cadre under Career Advancement Scheme, as per UGC/State Government norms, afresh; that faculty members willing to apply may submit their duly filled in application along with required enclosures in the prescribed format to the Registrar, through proper channel, **on or before 30.10.2015.**

Now, it is found that the Regular Teaching faculty members of the Tamil Nadu Dr.Ambedkar Law University are submitting their applications in different formats. For the maintenance of uniformity in consonance with the UGC norms, eligible regular Teaching faculty members are required to submit **their application in the "PBAS Proforma for Promotion under Career Advancement Scheme"**, as annexed herewith, **instead of the previous format.** The faculty members who have already submitted their application are also required to submit their application afresh in the 'PBAS Proforma for Promotion under Career Advancement Scheme', as annexed herewith. The last date for submission of filled in application is extended upto **13.11.2015.**

The eligible Regular Teaching faculty members who have not submitted their applications so far may submit their duly filled in application in the 'PBAS Proforma for Promotion under Career Advancement Scheme", along with required enclosures in the prescribed format in eight sets to the Registrar, through proper channel, **on or before 13.11.2015.**

The concerned Heads of Departments are requested to bring it to the notice of all the faculty members and to forward the duly filled in applications submitted by faculty members, to this office within the stipulated time.
