Applications are invited from qualified persons for the following posts in this University.

1. REGISTRAR: 1 Post [OC]

Qualifications:

- [i] Academician in the field of law not lower in rank than that of the Principal of Law College*, or the Professor of the University who has put in a service in such capacity for a period of not less than three years or an officer of the Government not lower in rank than that of the Deputy Secretary to Government, Law Department.
- [ii] **Pay Band:** PB Rs.37,400-67,000 + AGP Rs.10,000
- [iii] **Term of appointment:** For a period of 3 Years.
- [iv] **Age:** Should not have completed 55 years on the date of this Notification.
- [v] Preference will be given to those having knowledge in Tamil.

2. CONTROLLER OF EXAMINATIONS: 1 Post [OC]

Qualifications:

- [i] Academician in the field of law not lower in rank than that of the Lecturer (S.G./ Assistant Professor (S.G.) of a College*.
- [ii] **Pay Band:** Pay will be fixed w.r.t. his/her pay in the primary cadre.
- [iii] **Term of appointment:** For a period of 3 Years.
- [iv] **Age:** Should not have completed 55 years on the date of this Notification.
- [v] Preference will be given to those having knowledge in Tamil.

* **Note:** As per Sec 2(e) under Chapter I of the Tamil Nadu Dr. Ambedkar Law University Act, 1996, " 'college' means a college or institution established or maintained by or affiliated to the University and providing any course of study or training in law for admission to the examination; for degrees, diplomas or other academic distinctions of the University."

- Applications from candidates in service will be considered only if received through proper channel.
- Incomplete applications and applications which do not satisfy the required qualifications will be summarily rejected without notice.
