### CIRCULAR

It is informed that the instruction classes of the U.G. Courses for the even semester of the academic year 2018-2019 is scheduled to be commenced on 03.12.2018 - Monday. Therefore, **the eligible students** who are pursuing 2<sup>nd</sup> year to final year of the 5 year Integrated and 3 year (Hons.) Degree Courses and eligible to move to the next higher semester are required to pay the tuition fee for the even semester as mentioned hereunder:-

- The eligible students are required to pay the tuition fee in any one of the **INDIAN BANK BRANCH** through CHALLAN. The Green colour challan form can be had from the Office of the U.G. Courses, SOEL **from 15.11.2018 onwards.**
- Tuition fee paid through Demand Draft will not be accepted.
- The eligible students after paying the semester fee shall get a receipt from the Office of the School of Excellence in Law. The Receipt Date will be the date of admission. Though the student pays the fee before the stipulated time, until and unless the bank challan is submitted in the office, his name will not be entered in the attendance register.
- In other words, the name of the concerned student will be entered in the attendance

register of the respective higher semester and attendance will be calculated only from the date student submitted the bank challan in the Office of the School of Excellence in Law, i.e. from the date mentioned in the receipt issued by the University.

- The students shall not attend the instruction classes without paying the even semester tuition fee.
- SC/ST/Scheduled Caste students converted to Christianity, Differently Abled students and First Graduate students who are eligible to avail the tuition fee exemption are exempted from paying the tuition fee.

Payment of Even Semester Tuition Fee : **from 15.11.2018 to 24.11.2018**  
without penalty

Payment of Even Semester Tuition Fee : **from 25.11.2018 to 30.11.2018**  
with penalty

- Penalty of **Rs. 50/-** will be levied for each day in addition to the tuition fee. The penalty shall also be paid through Bank challan only.
- No further time extension will be given under any circumstances.
