It is informed that the instruction classes for the Under Graduate (Hons.) Degree Courses for the ensuing Even Semester of Academic Year 2019-2020 is scheduled to be commenced on Monday, 9th December 2019. Therefore, the students who are pursuing second year to final year of the 5 year integrated and 3 year (Hons.) U.G. Degree Courses and eligible to be promoted to the next higher semester are required to pay the prescribed tuition fee for the even semester of the Academic Year 2019-2020 as follows:

- > Students are required to pay the Tuition Fee in Indian Rupees in any Branch of the Indian Bank by way of Academic Payment Challan available in University Website: www.tndalu.ac.in
- Tuition Fee paid through Demand Draft will not be accepted.
- Penalty of Rs.50/- (Rupees Fifty only) will be levied for each day in addition to the tuition fee. The penalty fee shall also be paid through Bank Challan only.
- No further time extension will be given under any circumstances.
- After paying the semester fee, the name of the student will be entered in the Attendance Register of the respective higher semester, only on submission of the Bank Challan in the office. Attendance will be calculated only from the date on which the student submitted the Bank Challan in the Office of the School of Excellence in Law.
- > The students shall not attend the instruction classes without paying the Even Semester Tuition Fee.
- SC/ST/Scheduled Caste students converted to Christianity, Differently Abled Students and First Graduate students who are eligible to avail the Tuition Fee exemption are exempted from paying the Tuition Fee in the Even Semester also.
- Since NRI Students were required to pay the Tuition Fee and Special Fee per annum in the Odd Semester itself, they need not pay the Tuition Fee in the Even Semester.

Fee once paid will not be refunded.
