Separate applications are to be submitted in case of candidates applying for more than one post.

GENERAL INSTRUCTIONS

1. Application form duly filled by the candidate must be supported by attested copies of documents as proof of academic qualification, teaching and research experience.
2. Candidates shall have to produce all original certificates at the time of appearing for Interview.
3. Qualifications and other conditions applicable, are as prescribed in UGC Regulations 2018. The qualifying Degree must have been obtained in the relevant subject/specialization through **regular mode** only. **Degrees obtained through Open/Correspondence/Distance Education/Private Study are not eligible.**
4. Candidates must have obtained their Master's Degree in the relevant subject/specialization with minimum 55% of marks (relaxation of 5% marks will be provided in case of SC/ST/Differently Abled (Physical & Visual Impaired)).
5. The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for Interview. Where the number of applications received in response to an advertisement is large and it will not be convenient or possible to interview all the candidates, the University, at its discretion, may restrict the number of candidates to a reasonable limit on the basis of qualifications/experience higher than the minimum prescribed in the advertisement.
6. Candidates applying for the post of Professor and Associate Professor are advised to ensure that they possess the minimum research/API scores prescribed and evidence in this regard to be attached with the application.
7. The eligibility of the candidates will be determined on the basis of qualifications acquired by them on the last date fixed for receipt of applications.
8. Candidates applying for more than one post are required to fill separate application form for each post.
9. The reservation norms are as per the rules laid down by the Government of Tamil Nadu.
10. Candidates belonging to SC/SC(A)/BCO/MBC-DNC/ category must submit appropriate certificates issued by the competent authority as per the format prescribed by the Government of Tamil Nadu. Those who fail to submit the required certificates(s) will be treated as General Category, subject to fulfillment of other terms and conditions.
11. The candidates applying under PwBD Category are required to submit the Disability Certificate issued by competent authority in the prescribed format.

12. The University reserves the right to modify/withdraw/cancel any communication made at any time without assigning any reason. The University reserves the right either to fill or not to fill the posts without assigning any reason whatsoever.
13. The University reserves the option to verify the antecedents or documents submitted by the candidate at any point of time and in case of detection of infirmity or suppression of fact reserves the right to terminate the service.
14. In service candidates are required to send the applications through proper channel. In case of any difficulty, advance copy may be sent within the time prescribed subject to production of **NO OBJECTION CERTIFICATE** at the time of interview. No TA/DA will be paid to candidates called in for interview.
