Submission Themes/Topics

The submissions shall revolve around contemporary happenings and/or any relevant issue in relation to the Constitutional Law, Human Rights, or its interdisciplinary aspects, and must establish their relevance to the area of study that the journal specifies.

Eligibility

Quality contributions are invited from academicians, scholars, legal practitioners, students, and any eminent persons in the legal arena.

Categories

Submissions in the following categories are invited:

- Articles: 5000-7000 words (exclusive of footnotes)
- Notes & Comments: 3000–5000 words (exclusive of footnotes).
- Case Commentaries and Book Reviews: 1500–2500 words (exclusive of footnotes).

Guidelines for Submissions

- An abstract is required for all submissions except case comments and book reviews.
- Abstract must not exceed 400 words, including footnotes.
- Research Articles and Notes & Comments must contain five relevant keywords, to be indicated at the end of the abstract.
- Co-authorship with up to two co-authors is permissible. However, no author may submit more than one manuscript per edition, regardless of co-authorship status.
- Submissions must be original and neither published nor under consideration for publication elsewhere.
- Submissions are to be made in electronic form only and must be sent to jdchr2022@gmail.com. Submissions must be received on or before 30th of November, 2022.
- Authors will be intimated of the receipt of their submission within one week from the date of submission and will be sent for initial screening.
- The manuscript clearing the initial screening stage shall be subjected to plagiarism check in *Urkund* software available in the University. Manuscripts exceeding plagiarism of more than 20% shall be rejected in this stage. A rejection mail shall be sent to the authors in this regard.
- Intimation of Review Results: Within 15 days of Submission
- The Editorial Board has the final say on whether or not to accept the manuscript and publish it.
- No fees are to be paid at any stage for publication in the journal.
- All selected submissions will be awarded a Certificate of Publication.
- All submissions must be made through the email ID: jdchr2022@gmail.com. with the subject "Submission for Volume 1 in JDCHR".

Formatting Guidelines

• Language- British English.

• Layout and Spacing-

- a. A4 page size with Normal Margin (i.e., 2.54 cm from all sides).
- b. Abstract indented 1 cm from both, the left and right sides and italicized.
- c. The first line of every first paragraph of a new section starts with a right indentation (tip: press the tab button once).
- d. Line spacing of 1.5 in body text and 1 in the footnotes.
- e. Do not add space before or after paragraph, instead leave a blank line manually.

• Font-

- a. Times New Roman.
- b. Point size 14 for the main title of the manuscript, 12 for body text, and 10 for footnotes.
- c. Alignment of text needs to be justified, except for Main Title and Headings which are centred.

• Other Guidelines-

- a. Make sure of thorough citation check that involves checking if the hyperlink is functional, the pages have been correctly cited.
- b. Check for grammatical and spelling errors.
- c. Ensure that the citations are in accordance with ILI Footnoting format.
- d. All quoted text must be in inverted commas and italicized. Any quotes exceeding 30 words must be placed in a separate paragraph.
- e. All manuscripts will be checked for plagiarism, and those containing plagiarism over the permissible limit will be summarily rejected.
