# About the Workshop

This workshop is chaired by our Hon'ble Vice-Chancellor, Prof. (Dr.) N.S.Santhoshkumar, to facilitate the students of legal education across Tamil Nadu to develop their skill. In the modern era, most of the law graduates are moving towards Corporate field and hesitate to enter the legal fraternity. This is due to the absence of advocacy skill. With the support and assistance of our Hon'ble Vice-Chancellor, we planned to conduct a three days national level workshop on art of advocacy. This workshop will provide basic advocacy, presentation, of communication, personality development and drafting skills. The eminent speakers of the workshop include Hon'ble Judges of High Court of Madras. Advocate General. Additional Solicitor General and Senior Counsels from Madras High Court who will impart their valuable knowledge on the theme of the workshop. The main objective of this workshop is to inculcate to the law students about the various nuances of advocacy.

About the University

The Tamil Nadu Dr. Ambedkar Law University was established by the Government of Tamil Nadu by an Act of State Legislature. It was inaugurated by His Excellency Thiru K.R. Narayanan, President of India on September 20th 1997. Dr. Ambedkar Law University strives hard to develop in the students and research scholars, a sense of responsibility to serve the society in the field of law by developing skills in advocacy, legal services, legislation and law reforms through better educational instruction and research facilities. The University is functioning as a nodal agency to improve legal education in the State

of Tamil Nadu by affiliating the fifteen Government Law Colleges and nine private law colleges.

The flagship institution, the School of Excellence in Law (SOEL) run by the University has emerged as one of the premier Law Schools in the country.

Our university students have won several International and National Level Moot Court Competitions. The students of School of Excellence in Law have topped in IAS, IPS and IRS examinations too. Model United Nations, also known as MUN, an academic activity which leverage the legal skills by encouraging public speaking, research and teamwork has been conducted in the university with an active participation by the students. Special lectures, Workshops, National and International seminars, Conferences and Colloquium are conducted by the University. Eminent persons and high dignitaries' in the field of Law, Judges from Supreme Court of India and High Courts take part in the seminars and workshops held by the University. Now, the TNDALU has entered into a Memorandum of Understating with several academic and professional organizations with a view to provide quality legal education amongst its 4000 students.







### **About Madras Bar Association**

The Madras High Court was established in the year 1862 by a Royal Charter. Barristers who were practicing in the High Court formed an Association in the year1865. The Association was named as the Bar Association. From the available records, it is noticed that the first meeting of the Association was held on 14th March, 1865. To start with, only British Barristers were enrolled as members. After a decade or two, Indian Barristers were permitted to become members. Arnold White became the Chief Justice (1899-1914). When the High Court was shifted to the present magnificent building in 1892, a hall was given to the Madras Bar Association. In a meeting held on 30th April, 1898, it was resolved to name the Association as the "MADRAS BAR ASSOCIATON'. During the World War II, Madras High Court was shifted to a school in T.Nagar. This Association was also shifted to 18-A, Rajabathar Mudaliar Street, 6th **Iuly**. 1942.After T.Nagar, on Independence, the number of Barristers' dwindled. In 1951, it was decided to admit advocates who obtained law degrees from Indian Universities as Members, In 1983, for the first time, Mr.M.R.Narayanaswamy, a Non - Barrister, was elected as the President.
