The essays for the said Competition will be sent to the concerned District Court Campus either by the student / principal of the college, on or before 18th January 2023. The essays received may be evaluated and the top three best performers (District winner, 1st Runner up and 2nd Runner up) may be selected from your district and the same may be informed to TNSJA on or before 20th January 2023. The essay of the District winner (1st place) from your respective district shall be sent through email to TNSJA email id: tnsjacompetitions@gmail.com on the same day of declaring the result and the hard copy of the same may be dispatched through Courier to Tamil Nadu State Judicial Academy.

I am also to state that the Refreshment Bills (Tea & Snacks) for organizing the aforesaid Competitions will be settled by TNSJA. GUIDELINES FOR THE ESSAY WRITING COMPETITION

- The topic for the Essay Writing Competition is ""Empower the Future Protection of Rights of Children / குழந்தை உரிமைகள் பாதுகாத்து; எதிர்காலத்தை உறுதியாக்கு!"
- Language of Essay Writing Competition is either English or Tamil.
- ➤ The word limit for the Essay Writing Competition is 700 to 1000 words.
- ➤ Law Students pursuing 5 year LLB / 3 year LLB are eligible to participate in the Essay Writing Competition.
- The participants will send their essays in typed format / neatly handwritten, along with the copy of their College Identity Card by way of post / courier to the District Court Campus of their respective district (or) the Principal of the said College shall collectively send the essays, on or before 18th January 2023.
- ➤ A participant can participate in only one district.
- ➤ The Principal District Judges shall constitute a selection panel consisting of Two or Three Judicial Officers.
- ➤ Judging will be based on the knowledge of Child Rights and related Acts, precision and originality of ideas, command over language, style and vocabulary. Plagiarism should not be entertained.

- The Judges will evaluate the received essays and best 3 performers will be the winner, 1st runner up and 2nd runner up.
- > The decision of the panel will be the final.
- The List of the winners from the district may be communicated to TNSJA on or before 20th January 2023.
- The essay of the District winner (1st place) from your respective district shall be sent through email to TNSJA email id: tnsjacompetitions@gmail.com on the same day of declaring the result, and hard copy of the same may be dispatched through Courier to Tamil Nadu State Judicial Academy.
- > On receipt of the essays, TNSJA will evaluate the received essays and Three best performers will be declared as the State Level Winners.
- ➤ The Three State Level Winners will be awarded a Shield and Certificate of Appreciation during the Republic Day Celebrations to be held at the High Court of Madras.

GUIDELINES FOR THE ORATORICAL COMPETITION

- Language of Oratorical Competition is either English or Tamil.
- ➤ The time limit for the Oratorical Competition is 7 minutes.
- ➤ Law Students pursuing 5 year LLB / 3 year LLB are eligible to participate in the Oratorical Competition.
- Participant must carry their College Identity card at the time of reporting for the Oratorical Competition
- A participant can participate in only one district.
- ➤ The Principal District Judges shall constitute a selection panel consisting of Two Judicial Officers and One Professor from any one of the Law Colleges functioning in your district.
- ➤ Judging will be based on the knowledge of Child Rights and related Acts, command over language, expression, articulation, and vocabulary.
- \triangleright The best 3 performers will be the winner, 1st runner up and 2nd runner up.
- ➤ The decision of the panel will be the final.

- The winner (1st place) from the respective district will participate in the State Level Oratorical competition to be held on 25.01.2023 (Wednesday) at TNSJA Headquarters, Chennai.
- ➤ Three Winners will be selected in the State Level Oratorical Competition and they will be awarded a Shield and Certificate of Appreciation during the Republic Day Celebrations to be held at the High Court of Madras.
