(3) **Mode of Selection:** Candidates will be selected based on their marks in the qualifying examination and as per the rules of reservation of the Government of Tamil Nadu. (4) * Candidates who have completed 10+2+3 stream alone are eligible.

Dhinakaran Salai, Chennai – 600 028** by paying prescribed fee. Candidates seeking application by post are requested to send a requisition letter, mentioning the course to which they are willing to apply, along with requisite fee, to the **Registrar**. Candidates may also obtain application form in person from the **Principals of the Affiliated Government Law Colleges** by paying prescribed fee.

MODE OF PAYMENT OF APPLICATION FEE: (1) The candidates shall remit the prescribed application processing fee in any branch of **Indian Bank** through remittance challan which may be **downloaded from the University website or obtained from any one of the affiliated Government Law Colleges**. (2) The candidates may obtain the application form on submission of the remittance challan only. Application processing fee paid through Cash/Demand Draft/Money Order/Cheque/Bank Pay Order etc., will not be accepted. (3) To avail concession on application processing fee, SC(O)/SC(A)/ST candidates belonging to Tamil Nadu shall submit a attested photocopy of the permanent community certificate along with the remittance challan.
