

## REQUIRED INFORMATION FOR NRI CANDIDATES

### MODE OF PAYMENT OF FEES FOR NRI

Candidate selected for admission should pay the prescribed fee in any one of the following three modes:-

- (1) Remittance of Fee may be made by way of **Demand Draft** in USD drawn in favour of '**The Registrar, The Tamil Nadu Dr. Ambedkar Law University**' obtained from a bank abroad by the sponsorer.
- (2) If the sponsorer is maintaining NRE Account with any bank in India, remittance of fee may be made by way of a **Demand Draft** in USD drawn in favour of the '**The Registrar, The Tamil Nadu Dr. Ambedkar Law University**' by debiting from the account of the sponsorer.
- (3) Remittance of fee may be made by way of **SWIFT**. The Tamil Nadu Dr. Ambedkar Law University is maintaining Bank Account with Canara Bank, Kotturpuram Branch, Chennai. The sponsorer abroad may approach his/her banker for remittance of fee by making an application to remit the amount through **SWIFT**.

Candidates must furnish duly attested photo copies of the following documents along with the filled in application:

1. NRI status Certificate issued by the Indian Embassy of the respective Country with seal **(OR)** Copy of the Permanent Resident Card **(OR)** Green Card of the NRI.
2. Photo copy of the valid Passport of the NRI.
3. Photo copy of the NRE (Non-Resident External) **(OR)** NRO Bank Account Pass Book of the NRI.
4. Certificate of relationship between the NRI and the Candidate (issued by the Competent Authority).
5. Employment Certificate of the NRI. (In case of Self-Employment, nature of the business, annual income and required proof of Income Tax payment [for the last 3 years])
6. Qualifying Mark Statement/Grade list of the candidate.
7. Certificate showing that the candidate has proficiency in English Language.
8. School / College Transfer Certificate and Migration Certificate wherever necessary.
9. Two passport size photographs (in addition to photo affixed in the application).
10. Proof of Date of Birth.
11. Proof for place of birth and nativity.
