Bloom's Taxonomy is a classification system which is used to define and distinguish the different levels of human cognition. The Tamil Nādu Dr. Ambedkar Law University adopts Benjamin Bloom's Taxonomy in bringing desired course outcome at the end of each course being offered to students of various disciplines. The following 6 levels are proposed by Benjamin Bloom that is used to structure the learning objectives, lessons, and assessments of each course.

Bloom's Cognitive Level	Key Verbs	Methods used to check the attainment of Course Outcomes
Remember K1	List, recite, outline, define, name, match, quote, recall, identify, label, recognize.	At the end of the lecture or at the beginning of the lecture next day, students are randomly picked to recall and summarize the discussed matters in the class. By this method the subject faculties will be able to access the level of remembrance about what is dealt in the class.
Understand- K2	Describe, explain, paraphrase, restate, give original examples of, summarize, contrast, interpret, discuss.	Through Mid Semester Examination (MSE) and End Semester Examination (ESE), the understanding levels of the students are accessed, as he or she is able to reproduce in her own words, what she or he has understood from the lessons taught in the course.
Apply- K3	Calculate, predict, apply, solve, illustrate, use, demonstrate, determine, model, perform, present	Moot Court, Internship, Court Visits, Field Exposures are offered to students, by which they will be able to apply their learning.
Analysis- K4	Classify, break down, categorize, analyze, diagram, illustrate, criticize, simplify, and associate	In End and Mid Semester Examination, analytical questions are given to test the reasoning skills of the students. The Class Quiz Tests, Assignments are used as methods to check the logical and legal analytical skill of the students.
Evaluate- K5	Choose, support, relate, determine, defend, judge, grade, compare, contrast, argue, justify, support, convince, select, evaluate.	Besides the End and Mid Semester Examination, the Field Exposures, Class Presentation, Viva Voce and Labs are offered to evaluate and check their learning process.
Create- K6	Design, formulate, build, invent, create, compose, generate, derive, modify, and develop.	Students come out with Projects, Seminars, Assignments which they have created on the lessons that they have learned.
