**Dr. Ranjit Abraham, Registrar i/c, HOD of Department of Cyber Space Law and Justice, organised** this intellectual program with the vision of educating the cutting edge technology of Cyber Law and AI in the profession of Law and Para Legal aspects. He has been a Resource person in a National Workshop on Cyber law and Technological perspectives organized by Bharathiyar University and CODEFF Chennai, Panelist in a Panel discussion conducted by Human Rights Department of Ethiraj College on Cyber Law and Human Rights and in International conference organized by DRBCC Hindu College, Chennai, in National Workshop on Cyber law and Technological perspectives organized by Bharathiyar University and CODEFF Chennai, in the Digital Forensic Congress 2015 organized by the Asian Society of Criminology, ISC and University of Madras and copious conferences. *With the foresight of edifying the academic community in the growing phenomenon of cyber phenomena and legal profession, sir constituted this programme in a prime facet of understanding cyber intellectual ideas.*



**Dr. Raju Narayana Swamy** is an IAS officer highly known for his staunch stand against corruption. His online anti-corruption campaigns gained much significance. Currently, he is presiding as the Chairman of the Coconut Development Board in Kochi, Kerala. In 2018, IIT Kanpur conferred upon him the prestigious Satyendra K Dubey Memorial Award for maintaining highest professional integrity and honesty while serving his duty.

In 1989, he obtained a B.Tech. in Computer Science from IIT Madras and ranked first. Despite a full scholarship from the Massachusetts Institute of Technology (MIT), he decided to build a career in Civil Services. He topped the examination and joined the Kerala Cadre in 1991

In his administrative career, he has held several key portfolios including the Agriculture Production Commissioner and Principal Secretary (Agriculture), Kerala Government; Director of Fisheries and of Collegiate Education; Managing Director of Marketing Federation; and Commissioner in the Civil Supplies Department. Due to his uncompromising stand against corruption, he has faced several tribulations. In his 27 years of service, he has faced at least 22 transfers. He was felicitated with the Fourth IRDS award from the Institute for Research and Documentation in Social Sciences (IRDS), a Lucknow based civil society.

Reading and writing provided him the much-needed creative outlet and he went on to publish more than 26 books. His most popular one being Nano Muthal Nakshatram Vare. He won the Kerala Sahitya Akademi Award for his travelogue Santhimantram Muzhangunna Thazvarayil. For children's literature, he was awarded the Bhim Gold Medal and Kunhunni Awards and recipient of Satyendra K. Dubey Memorial Award, 2018 by IIT Kanpur.

Mr. Swamy has a quest for knowledge and treats learning as a game. He holds a post-graduate diploma in IPR from the National Law School, Bengaluru; a professional diploma in Public Procurement from the World Bank; an honorary doctorate degree from the Amrita Vishwa Vidyapeetham (2011); and **Homi Bhabha Fellowship to study Cyber law**. He is also the first ever civil servant to complete all the ten courses conducted by the National Institute of Disaster Management, New Delhi.

The Special Speaker elucidated the superseded approach of Artificial Intelligence in all the sectors with his rich intellectual practical experiences. He enlightened the students and faculties with a diversified approach in tech savvy laws and its consequences in days to come.
