





Annexure - 1: Instruction to the Candidates

Candidates are required to read the following Instructions carefully before filling the Exam Application Form

1. July 2021 Examinations will be conducted only through Online Mode and there is no change in the Question paper pattern of Examination.
2. a. For candidates (other than First year) of all the courses admitted before the academic year 2020-2021: All current even semester and their arrear examinations of 5 year/3 year Honours Degree Courses of the SOEL and 5 year B.A.B.L./B.A.LL.B. and 3 year B.L./LL.B. Degree Courses of the Affiliated Law Colleges shall be conducted.
b. For the First year candidates of all the 5 year Honours Degree Courses (SOEL) & 5 year B.A.LL.B Degree Course (Affiliated Law College) admitted during the academic year 2020-2021: First and Second Semester Examinations shall be conducted with a time gap of minimum 25 days between both the semester examinations.
c. For the First year candidates of 3 year Honours Degree course (SOEL) & 3 year LL.B Degree Course (Affiliated Law College) admitted during the academic year 2020-2021: First Semester Examinations shall be conducted.
d. All arrear examinations for arrear students who had completed the course shall be conducted.
3. Candidates shall apply for the examination only through online mode by visiting the University website: www.tndalu.ac.in and fill and submit the exam application form.
4. Candidates are required to register for the papers according to their batch and regulation and also instructed to refer the Time-Table for registering the correct subject code.
5. The Examination fees shall be remitted by way of Indian Bank Challan which can be downloaded from the University website.
6. The candidates are required to remit the appropriate examination fee along with the application cost and the mark statement fee. For fees details please refer backside of the Bank Challan.
7. Candidates are required to upload their clear and visible recent passport size photo.
8. **Visually Challenged Candidates:** Visually Challenged candidates are exempted from payment of examination fees. However they should pay the fees for Statement of marks and application cost.
9. The fees once paid, will in no circumstances be refunded or held over for the subsequent examinations.
10. Candidates are instructed to take a clear and visible photo of the remitted Exam fees Bank Challan and they should save the Image file name with their Register Number and upload the same in the online application form. The file size should be less than 1mb.
(For Example if the Register Number is 3I6A0001, the image file name should be 316A0001.jpg)
11. The last date for registration and payment of Examination fee is on or before 7th July 2021.
12. **NON-COMPLIANCE OF THE ABOVE INSTRUCTION, THE CANDIDATURE FOR THE EXAMINATION WILL BE SUMMARILY REJECTED.**
