The Bar Council of India under its Legal Education Rules mandates extensive training in Clinical Legal Education, Internships and Continuing legal education which has to be implemented through concerned Law Universities/Colleges/Schools.

In furtherance of this objective, the Bar Council of India has resolved for "Online Clinical Training Programmes for Law Students" and has authorised All India Reporter Pvt. Ltd. And ALARC to conduct training programmes/courses for Law students, young lawyers and teachers, through BCI Resolution No. 88/2015 dated 02.05.2015 copy of which is enclosed. Whereas PARTY OF THE SECOND PART THE TAMIL NADU DR AMBEDKAR LAW UNIVERSITY is a statutory body came into existence through a Notification under the Tamil Nadu Dr. Ambedkar Law University Act, 1996 (Act 47 of 1997) for the advancement and promotion of learning and knowledge of law in the educational pattern of the State in pursuance of the objectives and functions of the University under Sections 3, 4 and 5 of the said Act.

AND WHEREAS PARTY OF THE FIRST PART in furtherance to its aforesaid objectives offered the University to introduce AIR Education Support Suite [Annexure A] to the PARTY OF THE SECOND PART and to provide support to empower law students & equip them with latest tools of legal knowledge and information for professional development of law students, teachers & young lawyers.

AND WHEREAS for the said purpose PARTY OF THE SECOND PART hereby agrees to permit the PARTY OF THE FIRST PART to support the PARTY OF THE SECOND PART to establish and run the AIR Education Support Suite and infuse this unique process into the curriculum of legal education through 3 Year & 5 Year Law Degree Courses and also to the research scholars so as to enhance quality of legal education by infusing Clinical Legal Education.

AND WHEREAS PARTY OF THE FIRST PART in furtherance to its aforesaid objectives approached the PARTY OF THE SECOND PART to establish Centre of PRACTICAL ORIENTATION and run an AIR Education Support Suite activity in space available near Auditorium of the administrative block, admeasuring about 3800 Sq Ft. for works proposed in the Project "AIR Education Support Suite" concerning the development of legal profession and legal as well as continued clinical legal education in its Perungudi [Main] Campus.

AND WHEREAS PARTY OF SECOND PART agrees to establish ADR Learning Centre and Centre for Para Legal Services at the said premises.

AND WHEREAS for the said purpose THE PARTY OF THE SECOND PART is agreeable with the said offer and hereby grants permission to the PARTY OF THE FIRST PART to establish such Support Centre to achieve the said objectives and will incur all expenditure to develop the same.

AND WHEREAS, BOTH PARTIES OF THE FIRST PART & PARTY OF SECOND PART have mutually agreed and arrived onto the understanding that the establishment of 'AIR Education Support Suite', shall be done in the collaboration of both the Parties, for the said purpose of extending benefits to the students and legal fraternity.

AND WHEREAS both the Parties after deliberating on all the aspects for the said purpose have decided to entrust work on mutually agreed terms between the parties herein for a period of Ten years to be extended further for next Ten years as the PARTY OF THE FIRST PART is investing substantially huge amount.

THAT THE PARTY OF FIRST PART shall extend services for the purposes stated above in the Preamble of this MOU. The PARTY OF SECOND PART agrees to lease the above said premises to use the space and infrastructure in the The Tamil Nadu Dr Ambedkar Law University Perungudi Campus in furtherance of the legal and clinical legal education.

The above Online Services will be offered on Free of Cost to the Faculty Members of the University. In case, Faculty of affiliated colleges requires to use such services they need to pay an amount of Rs. 1000/- per year.

Distribution of Amount

The amounts so generated from the student Fees will be shared between the Parties in the following ratio:

- 70% for the PARTY OF FIRST PART to compensate the expenses provided for the infrastructure and huge investments and recurrent expenditures;
- 30% for Party Second Part (the University) for facilitating the programmes effectively.
- Further all amounts raised from organizing special programmes including ADR & Para Legal Services will be shared in the same proportion viz, 70% to (ALARC) and 30% to the TNDALU
- The fee structure specified above for the students may be revised by the Parties after a period of three Years depending upon the cost escalation basing on Yearly Price Index of Government of India in the ensuing years on mutually agreed terms and conditions. Such increase shall be prospective for the new entrants.

7. The PARTY OF THE FIRST PART is allowed free access to the students, teachers, and research scholars through the said 'AIR Education Support Centre' in order to execute programmes, workshops, trainings, and advanced clinical legal programmes to suit the needs of students of PARTY OF THE SECOND PART.
8. The PARTY TO THE FIRST PART will endeavour to secure maximum participation of the students, teachers & research scholars in the activities conducted by the Centre for Professional excellence.
9. The PARTY OF SECOND PART agrees that the Practical Orientation & Training Programmes shall be provided to law students at least once in three months.
10. That fees collected for professional & clinical training programmes, workshops, short-term & long term clinical courses, and other related programmes, shall be shared by PARTIES OF THE FIRST PART and SECOND PART in the ratio of 70 30.
11. The PARTY TO THE FIRST PART shall have the complete ownership of 'AIR Education SUPPORT SUITE', both premium & basic version and the associated intellectual property rights vested therein and that PARTY TO THE SECOND PART agrees that it will not utilize, transfer or sell the same in any manner whatsoever.

Provided that, any intellectual property rights that may arise from any activity conducted by the Centre in which both the Parties participate shall be under the joint-ownership of both the Parties to this MOU and can be utilized by either of the Parties, but only upon prior written communication.
12. That PARTY TO THE SECOND PART shall support in providing access and permission to record Audio-Video Lectures of LIVE Class-room teachings, Lecture Sessions of proficient academicians to PARTY OF SECOND PART and that the same can be disseminated through customized web portal for benefit of the students of the PARTY OF SECOND PART and law students.
13. That PARTY TO THE SECOND PART shall support PARTY OF THE FIRST PART in developing study material/literature on the theoretical and clinical legal subjects.
14. That PARTY TO THE SECOND PART shall undertake to facilitate the conduct of various programmes of the PARTY TO THE FIRST PART by providing material, personal and intellectual support through its faculty, students and supporting staff.
15. That PARTY OF THE FIRST PART is allowed to have access to the students for conducting Psychometric and Aptitude tests.
16. 17. That the above said allotted space is to be used only for the aforesaid Educational purposes of the law students, research scholars and Law Teachers; the PARTY OF FIRST PART shall use its name and logo in all such works.
18. The PARTY OF THE FIRST PART is allotted the space for the purposes set out in this MOU for a period of 10 years and since the PARTY OF THE FIRST PART would be incurring heavy expenditure on setting up the facilities and the PARTY OF SECOND PART hereby agrees not to terminate this MOU before the said period of Ten years in any event.
19. The Parties to the present MOU hereby agree that in case of any disagreement, difference or dispute arising out of any matter including interpretation of the MOU shall as far as possible be resolved through negotiation, mediation and conciliation. As a last resort the Parties shall refer the matter to mutually agreed Sole Arbitrator who shall be a retired Judge of High Court. The Arbitration Proceedings shall take Place in the University Premises and shall be completed with maximum of 5 sittings. The entire expenditure incurred in this ADR Mechanism shall be borne equally by both the Parties to this MOU.
20. That it is agreed between the Parties that both the Parties shall make all endeavors to ensure the full implementation of the MEMORANDUM OF UNDERSTANDING between the parties.
21. Any amendment to this MEMORANDUM OF UNDERSTANDING shall be valid and shall come into force only when it is executed and signed by both the Parties to the present MEMORANDUM OF UNDERSTANDING with their mutual consent.
22. That both the Parties agree to take such necessary and proper steps for the effective implementation of this MOU.
