#### **MAIN THEME OF THE SEMINAR**

In today's uncertain world, "insurance" has become an integral part of our planning. In India, the insurance sector is growing at a swift rate of 15-20%. Together with banking services, insurance adds about 7% to the country's GDP. Insurance is a major instrument for the mobilization of savings of people, particularly from the middle and lower income groups, that are channelized into investment for economic growth. There is no gainsaying the fact that a large number of people from rural areas have got insurance cover because of the campaigns and strategies adopted by the Government and the insurance companies. It is also true that insurance is understood by many people as an instrument to save tax. It is never considered as a medium for investments for a long time. In the Indian mindset, savings can be done only in banks and post offices in terms of fixed deposits. For a layman, insurance means managing risk. But today, insurance has moved out from being a mere risk coverage activity to that of an attractive investment avenue for the common man.

Insurance has a long and deep rooted history in India as seen from references to some form of it even in ancient texts. After Independence, the life insurance sector was nationalized in 1956 and the general insurance business in 1972. Life Insurance Corporation of India had monopoly over Indian Life Insurance sector till the late 1990s. But after the entry of private insurance players allying with foreign insurance experts, the Indian insurance market has turned into a highly competitive one. This led to major growth in the sector. However, more than three fourths of India's insurable population has no life insurance, pension cover or post retirement protection cover. Obviously, this sector has tremendous potential for growth as there is still a huge untapped market.

The Insurance sector in India is mainly governed by the Insurance Act,1938; the Life Insurance Corporation Act,1956; General Insurance Business (Nationalization) Act,1972; Insurance Regulatory and Development Authority (IRDA) Act,1999 and their related rules and regulations. Besides, Motor Insurance Act,1988; The Public Liability Insurance Act,1991; The Employees Compensation Act,1923 and the Consumer Protection Act,1986 are other legislations that deal with insurance-related issues.

Insurance is a contract of good faith (uberrimae fidei) and the entire insurance business rests on the mutual trust and harmonious relationship between the insurer and insured. Despite the enactment of several laws to safeguard the interests of the insured with regard to life insurance, health insurance, vehicle insurance, fire insurance, crop insurance, and so on, several people feel that insurance companies take them for a ride in different ways: selling of policy by presenting a false picture, non-disclosure of hidden charges, partial or total repudiation of claims on technical grounds, payment without interests, delay in policy delivery or settlement of claims, etc. There are complaints against some of the insurance agents of being indifferent once their policy is sold. The insurance companies, on the other hand, have their own problems such as non-disclosure of material facts by the people taking the policy (especially with regard to life and health insurance), submission of fraudulent/ bogus claims, exaggerated claims, belated claims, etc.

There is no doubt that the insurance sector has made great strides and has the potential to contribute significantly to the country's growth. It is therefore imperative that we examine the key issues, trends and challenges facing this sector. All these issues have to be addressed by academicians, advocates, people from the insurance sector and all other stakeholders. Being committed to consumer welfare, the Chair of Excellence on Consumer Law and Jurisprudence, The Tamil Nadu Dr. Ambedkar Law University is organizing an one-day national seminar on 'Insurance Services: Issues and Challenges' on 26<sup>th</sup> November, 2016 with the following sub-themes:

# THEME OF THE WORKSHOP

We are living in the age of the internet revolution. Utilizing digital resources has transformed the way in which we lead our daily lives- to communicate, commute and even the way in which we consume. Despite the difficulties in handling and using technology, more and more people are purchasing products online, thanks to the social media and online forums. Trading websites and online stores have given the modern consumer the benefit of increased access, choice and convenience.

According to Statista 2017, the percentage of the world's population with access to the internet has grown from 1% in 1995, to almost 50% in 2017. During the same time frame, e-commerce has grown at a dizzying pace. In 2016, an estimated 1.61 billion people worldwide purchased goods online. In 2016, global e-commerce sales amounted to 1.9 trillion U.S. dollars and projections show a growth of up to 4.06 trillion U.S. dollars by 2020. Use of smartphones has also seen a phenomenal growth in the last few years. More transactions are now being done via mobile phones. Statista 2017 projects the growth of smartphones from 2.1 billion in 2016 to 2.5 billion in 2019. Just over 36% of the world's population is projected to use a smart phone this year, up from about 10% in 2011.

According to a March 2016 study, 46% of internet users in the Asia Pacific region and 28% of those in North America had purchased products via a mobile device. These mindboggling figures also point to the need and urgency of acting swiftly to protect the interests and rights of consumers worldwide. The Consumers International Organisation (CI) has aptly come up with the theme 'Making digital market places fairer' to mark the World Consumer Rights Day on 15th March.

Online shopping enables people to buy anything from clothes, music and films to gadgets and groceries; booking and paying for transport, accommodation or buying tickets to events. However the biggest problem is that there is no guarantee of a product's quality. Fraudulent sellers who intentionally mislead customers to increase sales are the prime reason for substandard goods being passed off as quality stuff. There are also delivery and logistics issues, digital payment failures, unclear return and guarantee policies, lack of protection of sensitive information etc. which confront and confuse consumers. Consumers International (CI) has identified three key issues potentially faced by consumers as focus areas in its campaign for the current year: (i) access and choice; (ii) online Security and (iii) redress.

Although online shopping provides access to a variety of products in a single click and the opportunity to compare the prices amongst it, there are various issues arising out of it. To be on the safe side, the consumer is advised to check online reviews and background information regarding merchants prior to purchase, return and shipping policies, warranties, additional charges etc. and thoroughly inspect the goods upon receipt.

With regard to the second issue of online security, consumers' fears arise from scams or any unfair, unclear and confusing business practices such as Drip Pricing (accertising a headline price at the beginning of the purchase process following which additional fees, taxes or charges, which may be unavoidable, are then incrementally disclosed or dripped), Price Discrimination (charging consumers different prices according to their location, browsing history and operating system), Comparison Sites (hiding the websites that contain genuinely cheapest deals and promoting the websites that display high prices which are not reliable by getting commission from those websites) or lengthy Terms and Conditions and Disclosure Statements in opaque language leaving the consumers the only option to click or tick 'I agree'. In addition to the above, quite a few online traders purchase reviews that encourage consumers to buy goods and services.

Regarding the redressal of grievances, often consumers are faced with the anxiety of purchasing from foreign companies or the disappointment of not receiving the item as anticipated or in the desired condition. When shopping across-border, problems relating to redress are amplified. Cross-border dispute resolution is cumbersome, expensive and time-consuming. Another obstacle for consumers in buying across borders is finding that their contract is either subject to a foreign law, or may be dealt with in a foreign court, or that their contract is subject to clauses that stop them seeking redress in a state sponsored forum. All these jurisdictional issues and lack of redress when things go wrong undermine the trust over e-commerce.

The United Nations Guidelines for Consumer Protection state that all consumers of digital products and services should be treated equitably, honestly and fairly at all stages of their relationship with product and service providers. In addition to that, OECD Recommendations on Consumer Protection in e-commerce (2016) also emphasizes fair and transparent business and advertising practices, information about businesses, goods and services, transactions, as well as adequate dispute resolution and redress mechanisms, payment protection, privacy, and education. As far as India is concerned, the proposed amendments to the Consumer Protection Act, 1986 are expected to add teeth to the existing provisions in the Information Technology Act, 2000 (as amended in 2008) to protect the interests of consumers with regard to e-commerce transactions.

In this background, the Chair of Excellence on Consumer Law and Jurisprudence (CECLJ) of the Tamil Nadu Dr.Ambedkar Law University, Chennai is organising a National Level Workshop on Consumer Rights in Digital Market: Need for Fair Play on 15th March, 2018 on the occasion of World Consumer Rights Day to discuss the key issues raised above. A cross-section of people including academicians, advocates and activists, students and scholars are expected to participate and share their views.



# Theme of the Colloquium

The evolutionary character of the norm of human rights in the legal world, national as well as transnational reflects loss of hope, in particular struggles is reast of Conflict. In the original sense, the value based notions of universal brotherhood, respect for human dignity, human security at the global level, and the necessity based thresholds of interdependence and unity in diversity have been capitulated by the conflict of East and West approaches towards human rights.

From the birth of the Human Rights in 1945, the facet of Human Rights traversed across the length and breadth of humanity and beyond. Its development at the international, regional, national and at the local level extended through the second generation rights to fifth generational rights. However, the cultural concepts of the Human Rights revolve around universality could not be established. This is because of the introduction of scientific technology perspectives and the differences between the cultures of the East and West.

In view of the differences between the concepts of West and East, conflicting situations take a front seat every time. These parallel regimes led to the division between the States on the horizontal and vertical perspectives of Human Rights. These situations impacted the cross border exchanges in policy, legislations and judicial decisions of the State.

As rightly noted that the scientific temper of law has brought in number of perceptual changes wherein the concept of equality before law remained only or paper but not strict adherence in practice. These upheavals may at times lead the scholars of East and West to exchange bitterness in the name of cultural relativism. The renowned jurist Prof. Bakshi openly advocated that 'West is not rest of the World'. The statement of Prof.Bakshi further substantiated by the stand taken in early 80's by the former Malaysian President Mohammad Mahathir on cultural relativism which questioned the credibility of the Universality of Human Rights. The cultural perspectives of Science and technology particularly the innovation of knowledge based technology, bio-diversity, genome technology, so far, so as though benefit the world as one platform, but could not address the pitfalls of universality of Human Rights.

advisory services, cash management services, tax advisory services etc. have increased the popularity of banks. But there are a few problems that have been plaguing the banking sector in our country - the problem of non-performing assets (NPAs), the increasing number of bank frauds, the threat of cybercrimes, the perception that banks cater more to the corporate houses and the urban elite than address the problems of the rural poor etc., In this context, the role of RBI as the regulator vis-à-vis the Government's policies has also come under public scrutiny.

The Banking Regulation Act, 1949, which regulates all banking firms in India, also gives RBI the power to regulate, control and inspect all Indian Banks. Does the Act need a relook in the light of the developments that have taken place in the banking sector in recent years? To what extent has the Prevention of Money Laundering Act, 2002, helped in tackling this serious problem? Do the provisions of the Consumer Protection Act, 1986 and the Information Technology Act, 2000 have enough teeth to redress the grievances of consumers with regard to banking services? The University is functioning as a nodal agency to improve legal education in the State of Tamil Nadu by affiliating the ten Government Law Colleges of Tamil Nadu and two private colleges. During its short existence, the School of Excellence in Law (SOEL) run by the University has emerged as one of the premier Law Schools in the country.

In the 18th Henry Dunant Memorial Moot Court Competition, 2018, which is one of the prestigious moot court competitions in the world, the team representing School of Excellence in Law, has won Best Researcher Award. The TNPSC has conducted a civil judge exam in the year 2018 in which 20 students of our University who underwent their UG /PG Courses in School of Excellence in Law have been selected and the 1st rank holder of Civil Judge Exam is from our university. The students of School of Excellence in Law have topped in IAS, IPS and IRS examinations too. Model United Nations, also known as MUN, an academic activity which leverage the legal skills by encouraging public speaking, research and teamwork has been conducted in the university with an active participation by the students. Special lectures, Workshops, National and International seminars, Conferences and Colloquium are conducted by the University. Eminent persons and high dignitaries in the field of Law, Judges from Supreme Court of India and High Courts take part in the seminars and workshops held by the University. Now, the TNDALU has entered into a Memorandum of Understating with All India Reporter and has launched AIR Online Education Suite and AIR Law Cafe with a view to provide quality legal education amongst its 4000 students.

#### **About Madras Bar Association**

The Madras High Court was established in the year 1862 by a Royal Charter. Barristers who were practicing in the High Court formed an Association in the year 1865. The Association was named as the Bar Association. From the available records, it is noticed that the first meeting of the Association was held on 14th March, 1865. To start with, only British Barristers were enrolled as members. After a decade or two, Indian Barristers were permitted to become members. Arnold White became the Chief Justice (1899- 1914). When the High Court was shifted to the present magnificent building in 1892, a hall was given to the Madras Bar Association. In a meeting held on 30th April, 1898, it was resolved to name the Association as the "MADRAS BAR ASSOCIATON". During the World War II, Madras High Court was shifted to a school in T.Nagar. This Association was also shifted to 18-A, Rajabathar Mudaliar Street, T.Nagar, on 6th July, 1942.After Independence, the number of Barristers' dwindled. In 1951, it was decided to admit advocates who obtained law degrees from Indian Universities as Members. In 1983, for the first time, Mr.M.R.Narayanaswamy, a Non - Barrister, was elected as the President.

Owning a house is one of the top priorities for most people, regardless of their income levels. According to the 2011 census, there are 246.7 million households in India, 68% in rural areas and 32% in urban areas. 95% of the households in rural areas and 69% in urban areas live in owned houses. Overall, 213.5 million or around 86% of all households were living in owned houses. The average household in India is 4.9 as per 2011 census. More than 40% of the households have just one room or no exclusive room in their houses which means that in 40% of the houses, 5 people have to share a room in the name of a house.

One of the priorities of the Central and State Governments has been to promote housing with focus on housing for the poor. Since independence, a large number of schemes have been launched under different names providing fiscal incentives both on the demand and supply side. The "Housing for all" scheme was launched by the Central Government in 2015 with the objective of constructing 20 million houses for the urban poor by 2022. The Government of Tamil Nadu has been in the forefront in promoting housing especially for the economically weaker sections and low income categories. While the Government sector has been focusing on housing for the low income categories, the demand for housing by the middle and higher income groups has been by and large met by the private developers.

According to the Global Cities report that came out a few months ago, Chennai will be one of the fastest growing cities in the world between 2019 and 2035. Foreign investment in Real Estate are set to scale new heights, thanks to growing economic environment giving rise to fresh employment opportunities, ease of doing business, improving air connectivity with world cities as well as better inter-city connectivity. Chennai, along with Bengaluru, Hyderabad, Mumbai, Pune and Delhi NCR currently attract the lion's share of NRI investments. Chennai has been welcoming migrant populations from States like Bihar, Jharkhand, West Bengal and the North Eastern States who are coming here for better opportunities. With the influx from rural areas also growing steadily, do we have the infrastructure to cater to their needs?

From the trend of individual houses to small apartments and then to large town ships with community living, the lifestyle of people in Chennai has changed in the last two decades. More and more vertical buildings are coming up changing the skyscape of the city. Though the costs of construction have gone up, easier availability of credit for this segment at affordable rates of interest has encouraged many people in the middle and high income categories to go for apartments and villas.

#### Problems of consumers

However, the consumers in the Real Estate sector are prone to a lot of vulnerabilities like unprecedented delays in construction and completion of projects, diversion of investor funds to other projects, failure to handover completed properties, arbitrary increase in the super built up area and consequent levy of additional charges, unreasonable one sided contracts, reluctance to pay even the minimal delay penalty by promoters, etc. Consumers have on occasions become victims of fraud or deception at the hands of unscrupulous real estate agents who take advantage of the lack of knowledge on part of consumers. They mislead home buyers regarding amenities and

#### **Problems of developers**

The developers also face problems due to uncertainties in the availability of raw materials like sand, cement etc. which not only increase the cost of construction but also result in delay in completion of projects. Getting approvals and clearances from authorities also take time. They have to deal with corruption at different levels which is another inhibiting factor. The stamp duty in our State is also very high compared to other States.

#### **Regulation of Real Estate Sector**

Though progressive, the real estate industry had not been well regulated. Provisions in the Indian Contract Act, 1872, Specific Relief Act, 1963, Indian Penal Code, 1860, Rent Control Act, 1948, along with Consumer Protection Act, 1986 (after 1993) Amendment Act) were regulating this sector to some extent. At the State level, the Tamil Nadu Town and Country Planning Act, 1971 and the Development Regulations framed there under had been used to regulate land use and development. A major development in recent years is the enactment of the Real Estate Regulation and Development Act (RERA), 2016. It is truly a revolutionary Act in the history of the Indian real estate sector. It was introduced to protect home buyers' interests and also to boost investment in the real estate sector. The Act aims to improve transparency and encourage fair practices in the sector. It also seeks to plug the glaring gaps between consumer interests and abuse of power by the real estate lobby by placing an effective regulatory mechanism for the orderly growth of the sector. It seeks to minimize consumer exploitation and diversion of funds, streamline usage of funds, ensure timely deliveries and enhance consumer confidence. The Real Estate Regulation Act (RERA) has made it safer for consumers to buy their dream houses.

#### However, there are a few areas of concern which need to be addressed:

- The Act only covers new projects and the projects where completion certificate is not issued on the date when the Act is notified, but not the existing projects i.e. the projects that are ongoing as on date or where partial completion certificate has been issued, completed immediately before the Act is notified, or stuck as on date for any reason;
- The Act doesn't make any provision for selling flats/apartments on carpet area basis, leaving a scope for promoters for manipulation;
- Under the Act, it is not mandatory to register projects, which are smaller than 500 square meters and 8 apartments. It could lead to the exclusion of a large number of small housing projects, which also have great share in the market.

Another legislation which is bound to bring cheer to the consumer is the Tamil Nadu Regulation of Rights and Responsibilities of Landlords and Tenants Act, 2017, which has made the registration of rent agreements mandatory in the State. This Act modeled from the Centre's Tenancy Act is expected to bring about a balance between the rights and responsibilities of both the owner and the tenant.

#### Issues to be discussed

There are many questions which arise in the context of what has been stated here: (i) how effective are the laws in protecting the rights of consumers in real estate (ii) will RERA be able to strike a balance between consumers' interests and developers' ambitions (iii) when will "Housing for all" become a reality not merely in terms of persons owning a house but also in terms of quality of living (iv) can the provision of infrastructure facilities like water supply, sewerage, power, roads and communication cope with growing population and increasing house stock especially in urban areas (v) will the rent courts and tribunals set up under the Act of 2017 ensure that the grievances of tenants and landlords are redressed quickly and (vi) can investment in housing be an attractive proposition for those who have the capacity to save?

To discuss the above and related issues, the Chair of Excellence on Consumer Law and Jurisprudence of the Tamil Nadu Dr.Ambedkar Law University, Chennai proposes to conduct a one day Workshop on "Consumers in Real Estate Sector: Winners or Victims on Friday 31st May 2019, from 2.30 p.m. at the University's old campus at "Poompozhil", No.5, Dr. D.G.S. Dinakaran Salai, Chennai – 600 028. Policy makers, experts in the field, academicians, consumer activists and students are expected to participate.




