It is informed that the 'Instruction Classes' for the even semester of 3<sup>rd</sup> year to final year of 5 year (Hons.), Final year of 3 year (Hons.) and 2<sup>nd</sup> year of 5 year (Hons.) Degree Courses for the academic year 2021-2022 were commenced from 15.11.2021 and 21.02.2022 respectively.
