



INSTRUCTION TO THE CANDIDATES

Candidates are required to read the following Instructions carefully before filling the Exam Application Form

1. Distance Education Courses Examinations of April 2022 will be conducted only through **ONLINE MODE** as instructed by the Government of Tamil Nadu.
2. Candidates shall apply for the examination only through online mode by visiting the University website: www.tndalu.ac.in and submit the exam application form.
3. Examination Schedule and Time-table are available in the University website and also in the notice board of the School of Excellence in Law.
4. Candidates are required to register for the papers according to their Courses (Master of Corporate Law and P.G. Diploma Courses) and also instructed to refer the Time-Table for registering the correct subject code.
5. Candidates are required to upload clear and visible recent passport size photo.
6. The students are required to pay the appropriate examination fee through Demand Draft drawn in favour of "The Registrar (A/c. DDE), The Tamil Nadu Dr. Ambedkar Law University payable at Chennai. Further, they are required to upload clear copy of the demand draft in the Examination application form and submit the original demand draft along with the duly filled in "Submission of Demand Draft form" which is attached herewith to "The Controller of Examinations, The Tamil Nadu Dr. Ambedkar Law University, Dr. M.G.R. Salai (Near Taramani Railway Station), Taramani, Chennai – 600 096" without fail. Failing to submit their demand drafts, the results will be withheld.
7. **Visually Challenged Candidates:** Visually Challenged candidates are exempted from payment of examination fees. However they should pay the fees for Statement of marks and application cost.
8. The fees once paid, will not be refunded under any circumstances or carry over to the subsequent examination.
9. **The last date for registration the examination and payment of examination fee is 21.03.2022.**
