### Rules and Regulations for E-Poster Making Competition

- File Size: Maximum file size is 10MB
- File Format: Save your file as a PDF for quick and easy upload
- Each participant should submit one entry only.
- The E-poster will be judged according to the following criteria: creativity, and presentation and relevance to the theme
- All poster entries must include the aforementioned theme and a related creative quotation can be used.
- Participant name or identifying mark must not appear on the E- Poster;
- All E-Poster should be original work of participant. Any participant found violating rules and regulation will be disqualified from competition.
- Decision of jury will be considered final.


