ORDER:

In the Government Order 1st read above, orders have been issued constituting an expert committee to finalize the methodology to be followed in computation of marks of eligibility of the candidates who have completed 3-Year Diploma / Polytechnic and eligible to apply for 5-Year law degree course in the Affiliated Law Colleges and School of Excellence in Law, Tamil Nadu Dr.Ambedkar Law University.

2. The Registrar(i/c), Tamil Nadu Dr.Ambedkar Law University in his letter 2nd read above, has forwarded the minutes of the above said Expert Committee meeting held on 15.05.2023 to the Government seeking necessary instructions for further compliance. The Expert Committee in its meeting unanimously resolved to recommend to the Government regarding computation of marks of eligibility and ranking of the candidates who have successfully completed 3-year Diploma / Polytechnic.

3. The Government, after careful consideration of the recommendations made by the Expert Committee, have decided to accept the same and orders accordingly. The guidelines on computation of marks and ranking of candidates who have successfully completed 3-year Diploma/ Polytechnic for admission into 5-year Law degree courses offered in the School of Excellence in Law and the Affiliated Law Colleges of the Tamil Nadu Dr. Ambedkar Law University are as follows: -

- (i) Exclude all Language Courses;
- (ii) The Marks secured in all the 'Theory Courses' in the 3 Year Diploma shall alone be considered for Ranking purpose and

the Practical Courses shall be excluded due to the reason that certain Diploma Programmes have Courses like,

- (a) Modern Office Practice - The Programme includes Typewriting, Desktop Publishing Lab;
 - (b) Mechanical Engineering ('L' Scheme) – Communication and Life Skill Practical;
 - (c) Mechanical Engineering (CPC 2012 'B' Scheme) – Workshop Practice;
 - (d) Automobile Engineering ('J' Scheme) – English Communication Practical;
 - (e) Civil Engineering ('K' Scheme) – Surveying Practice.
- (iii) The candidates who have studied 'Commerce OR Accountancy' or relevant subjects as 'Theory Courses' in any of the Diploma Course are also eligible to apply for 'B.Com.,LL.B.(Hons.) Degree Course', offered in the School of Excellence in Law of Tamil Nadu Dr.Ambedkar Law University.
 - (iv) The candidates who have studied 'Computer Science' or relevant subjects as 'Theory Courses' in any of the Diploma Course are also eligible to apply for 'B.C.A.,LL.B.(Hons.) Degree Course', offered in the School of Excellence in Law of Tamil Nadu Dr.Ambedkar Law University.

4. The Registrar(i/c), Tamil Nadu Dr.Ambedkar Law University is directed to follow the aforesaid guidelines while considering the candidates who have successfully completed 3-year Diploma / Polytechnic courses for admission to the 5-year Law degree courses offered in the School of Excellence in Law of Tamil Nadu Dr.Ambedkar Law University and the affiliated Law Colleges of the Tamil Nadu Dr.Ambedkar Law University from the academic year 2023-2024 onwards.
