**Respected Sir/Madam,**

**Sub:** Norms adopted by the Tamil Nadu Dr.Ambedkar Law university for conducting the Inter Law Colligate Tournament from academic year 2023-2024 onwards applicable for all affiliated Law Colleges (Both Government & Private)- Intimation.

The Tamil Nadu Dr.Ambedkar Law University is conducting the State Level Inter-Collegiate Tournament for the affiliated Law Colleges and School of Excellence in Law of this University every year. Around 25 Teams comprising of 24 affiliated law colleges which includes 15 Government Law Colleges and 9 Private Law Colleges & School of Excellence in Law will participate in the Inter-law Collegiate Tournament . The newly adopted norms for conducting tournament were approved by the 86<sup>th</sup> Meeting of the Finance Committee and 181<sup>st</sup> Meeting of the Syndicate of the University. All the respective affiliated colleges are hereby instructed to strictly adhere to the norms mentioned below *(A copy of the norms has also been uploaded in the TNDALU website.)*

**The Norms are as follows:**

1. All the affiliated law colleges should form a separate working sports committee. The Principal should be the President of the Committee and Physical Education Directors should be the Secretary. The Committee should also include one Female Teaching Faculty from the respective college and one eminent sports person from outside the institution also be nominated to the Committee by College Principal.
2. Once College reopens for the new academic year, as early as possible an official circular should be released and that should be published in the college notice board inviting players for enrolling in the respective sports discipline.
3. All the Physical Directors of the affiliated law colleges of the University are requested that **within a period of one month** after reopening for that semester an '**Internal Selection Trials**' has to be conducted to select the best players/teams representing the respective college. External experts should also be invited to adjudge the best players/teams. Based on the decision of the external experts and Physical Education Directors, the working sports committee constituted by the College should certify the players/teams and it should be intimated to the University at once.
4. No player other than who are selected by the Expert Committee on reopening of college and whose name has already been sent to the University shall be allowed to participate in the Inter-Collegiate Tournament.

5. The College should also maintain an attendance register from the date of selection and which should contain the details of Names of the players, specialization, date of birth and other relevant information, which shall be countersigned by the Principal and the Physical Director everyday. The Physical Director should maintain this register and it should be produced to the University on demand.
6. Regular sports practice sessions shall be conducted daily according to their own convenient time throughout the year in all working days. Players/teams who have not secured 75% of attendance through proper training are not allowed to participate in the Inter Law Collegiate tournament. This should be strictly ensured by the Physical Director of respective Government Law Colleges & Private Law colleges.
7. The Physical Directors should submit all documents of the selection process, training session attendance, selection list of players/teams to the University through proper channel before commencement of the Inter Law Collegiate Tournament.
8. It is the responsibility of the Physical Directors of the College to inform the University within a period of one month from the date of reopening of that semester about their participation in the various events of Inter Law Collegiate Tournament with individual player name.
9. Accommodation cannot be provided to the Colleges which fail to send their participation intimation and name list of the students within one month after reopening of the college for that semester.
10. The College should ensure that their students should follow the new rules and regulations relating to selection, training and all kinds of tournament rules.
11. If any player/team found violating any of the rules of the sports and games or indulging in any in-disciplinary activities during the Inter Law Collegiate Tournament, the respective player/team will be expelled from the tournament by the Organising Committee with immediate effect and they will be barred from participating in any College/University/Inter-University/National/International level sports/games for the period of 3 years.
12. With regard to payment of TA/DA to the players and Physical Directors, the Tamil Nadu Dr.Ambedkar Law University also will follow the norms of the State Universities in Tamil Nadu. *(A separate regulation for this has also been uploaded in the University website)*
13. Any damage caused by any player, including in the place of accommodation, shall be borne by the respective college and the Physical Director of that college will be directly responsible for all damages.
14. Government Law Colleges and Private Law Colleges should inform the University in advance and obtain permission if they wish to conduct any Inter-law collegiate sports events.
15. Physical Directors are empowered to replace the existing player by first year student if they are more proficient than the already selected player. This arrangement is made due to the late admission. In the event of replacement, that information with all particulars shall be sent to the University within one month of their admission in the college.

The participants at the Divisional Level, State Level Annual Championship Tournaments conducted by SDAT/SAI/Recognized State Association alone will be accepted.

All the Physical Directors of every Law Colleges are hereby requested to select the highest achievers in the above said events and send the relevant certificates to the University for scrutiny.

**III. The Hon'ble Vice Chancellor of The Tamil Nadu Dr.Ambedkar Law University Col. Prof.(Dr.) N.S.Santhosh Kumar took initiative in introducing cash incentives to the eminent sports persons for the achievement in AIU Inter University / National/International competitions.**
