

INSTRUCTIONS TO THE CANDIDATES

Candidates are required to read the following Instructions carefully before filling the Exam Application Form

- 1. May, 2024 Examinations will be conducted only through <u>OFFLINE MODE</u> and there is no change in the Question Paper Pattern of Examinations.
- 2. Examination Schedule and Time-Table is available in the University website and in SOEL office notice board.
- 3. Examinations are conducted for the candidates of 5 Year & 3 Year Law Degree Courses as detailed below:

I. FOR 5 YEAR B.A.LL.B. LAW DEGREE COURSES:

- (i) For the candidates admitted during the academic year 2023 2024:
 - ➤ The 1st (ODD) Semester & 2nd (EVEN) Semester examinations shall be conducted.
- (ii) For the candidates admitted to the academic years from 2019 2020 to 2023 2024:
 - All current EVEN semester and their arrear examinations shall be conducted.
- (iii) For the candidates admitted to the academic year from 2017 2018 to 2018 2019:
 - > Permitted to write their arrear examinations.
- (iv) For the candidates admitted to the academic years on or before 2016–2017 other than Re-admitted candidates:
 - ▶ Permitted to write their arrear examinations as a final chance and it shall not be shown as a precedent in future As per the resolution passed by Syndicate in its 188th Meeting held on 30.03.2024 (Vide, Item No.11). Such candidates shall write their examinations on the dates fixed in the equivalent subjects of new regulation prescribed during the academic year 2016-2017. The details of equivalent subjects are available in Annexure-I.

II. FOR 3 YEAR LL.B. DEGREE COURSE:

- (i) For the candidates admitted during the academic year 2023 2024 (First year students of this academic year):
 - ➤ The 1st (ODD) Semester & 2nd (EVEN) Semester examinations shall be conducted.
- (ii) For the candidates admitted to the academic years from 2021 2022 to 2022 2023:
 - ➤ All current EVEN semester and their arrear examinations shall be conducted.
- (iii) For the candidates admitted to the academic year from 2019 2020 to 2020 2021:
 - > Permitted to write their arrear examinations.
- (v) For the candidates admitted to the academic years on or before 2018–2019 other than Re-admitted candidates:
 - Permitted to write their arrear examinations as a final chance and it shall not be shown as a precedent in future As per the resolution passed by Syndicate in its 188th Meeting held on 30.03.2024 (Vide, Item No.11). Such candidates shall write their examinations on the dates fixed in the equivalent subjects of new regulation prescribed during the academic year 2016-2017. The details of equivalent subjects are available in Annexure-I.

- 4. Candidates shall apply for the examination only through **online mode by visiting the University website**: **www.tndalu.ac.in** and fill the application form, pay the required fees and submit the exam application form.
- 5. Applications submitted through any other mode shall not be accepted.
- 6. In the online Exam Application form,
 - a. In **Student Particulars section**, candidates are required to update the necessary details viz. Mobile No., Email-Id, Address for communication, Scanned Passport size photo [File size: Max. 1 Mb], Aadhar No. (supported with proof of document) etc.,
 - b. In **Subject Particulars Section**, the candidate's current semester papers and arrear papers in both Internal and External will be displayed, wherein the current semester papers will be compulsorily auto registered and their arrear papers can be selected on choice.
 - c. In **Fees Particulars section**, the required fees to be paid will be calculated based on the number of subjects' enrolled + other applicable fees.
 - d. In **Exam Application Review section**, all details filled in by the candidate will be shown for confirmation / editing.
 - e. On confirmation, candidates shall pay the required fees through the online payment gateway.
- 7. Candidates are required to verify the details before submitting. No further corrections will be allowed.
- 8. **Visually Challenged Candidates:** Visually Challenged candidates are exempted from payment of examination fees. However they should pay the fees for Statement of marks and application cost.
- 9. The fees once paid will in no circumstances be refunded or held over for the subsequent examinations.
- 10. Copy of the filled-in Exam Application form will be forwarded to candidate's registered Email-Id or it can be downloaded from the University website.
- 11. NON-COMPLIANCE OF THE ABOVE INSTRUCTIONS, THE CANIDATURE FOR THE EXAMINATION WILL BE REJECTED.

THE DETAILS OF EQUIVALENT SUBJECTS OF OLD REGULATION WITH THE NEW REGULATION FOR THE CANDIDATES ADMITTED ON OR BEFORE THE ACADEMIC YEAR 2016-2017

As per the resolution passed by the Syndicate in its 188th Meeting held on 30.03.2024, the candidates who admitted on or before the academic year 2016-2017 in the 5 Year Law Degree Course and the candidates who admitted on or before the academic year 2018-2019 in the 3 Year Law Degree Course of the Affiliated Law Colleges will be permitted to write their arrear papers in the examinations to be conducted during May, 2024, as a one-time measure.

Further, such candidates shall write their examinations on the dates fixed in the equivalent subjects of new regulation prescribed during the academic year 2017-2018.

The details of equivalent subjects of old regulation with the new regulation is given below, so as to enable the above such candidates to apply and write the examinations, May 2024 without any disruption:
