Please refer to your application for the award of the ICHR's Research Project Grant. I am pleased to inform you that the 174th meeting of the Research Projects Committee held on 14.12.2023 has approved the recommendations of the Presentation-cum-Interview Committee on your Research Project proposal entitled "**History of Public Library Movement and Development in Tamil Nadu (erstwhile Madras) since 1850 to present times**".
