The ultimate goal is to empower participants to navigate complex ethical challenges, uphold the highest standards of integrity, and contribute to a culture of transparency and credibility in academic and research endeavors.

After undergoing the study the research scholars will be able to understand the following:

- Scholars will understand the core ethical principles, promoting honesty and transparency in research.
- Scholars will master plagiarism identification and prevention techniques, emphasizing proper citation practices.
- Scholars will practice research with ethical considerations, ensuring informed consent, data integrity, and responsible authorship.
- Scholars will grasp ethical aspects of publication, covering responsible authorship and effective
- Scholars will develop cultural sensitivity and awareness of emerging ethical challenges in the global research landscape.
