ABOUT ACS

The Asian Criminological Society (ACS) was established in 2009 in Macau, China with the following objectives: (1) to promote the study of criminology and criminal justice across Asia; (2) to enhance cooperation in the fields of criminology and criminal justice by scholars and practitioners; (3) to encourage communication between criminologists and criminal justice practitioners in Asia and the world through publications and conferences; and finally, (4) to foster training and research in criminology and criminal justice in institutions of learning, and in criminal justice agencies.

WHY CRIMINAL INVESTIGATION?

During a criminal investigation, which includes crime scene investigation, evidence is carefully gathered and examined. The purpose of a crime scene investigation is to determine what had transpired to identify the sequence of events leading to the actual crime, the responsible party and their modus operandi. It is helpful to recognise and properly gather physical and digital evidence when trying to solve and prosecute violent crimes. Whether physical evidence will be used in resolving or prosecuting violent crimes depends heavily on the law enforcement officer who saves and searches the crime scene. Firstly, not all lawyers are equally capable of seeking out and compiling evidence. The scope of evidence collection and crime scene investigation is not just limited to forensics students but every student/person connected to the criminal justice system is required to possess basic knowledge about crime scene investigation and evidences.

ABOUT THE COMPETITION

This program as an innovation departs from the usual custom of conducting moot court competitions. Criminal Investigation competition assesses the ability of students to perform procedures related to crime scene procedures and to hypothesize the suspects. It aims to learn more about crime investigation by examining physical evidences from the crime scene along with use of reasoning and logical skills. It is interdisciplinary, including identifying, reporting, sketching, identification, photography, reasoning and observational skills.

ABOUT THE WORKSHOP

The workshop is designed in such a way that the participants get to learn about investigating a crime scene, taking evidence and analyzing. It is to be conducted before the competition by a team of forensic experts who guide us on the do's and don'ts of a crime scene investigation with a live demonstration of evidence collection methodology is also to be imparted to the participants. Interested participants may register separately for the workshop alone

TEAM ELIGIBILITY & TEAM COMPOSITION

- This event comprise of competition and workshop.
- The competition is open to full-time students and full-time research scholars belonging to streams of Law, Criminology, Social work, Human rights, and Police administration and who are below the age of 30 years.
- Entry to the workshop is included for all participants of the competition.
- Academicians regardless of field of study can register for the workshop.
- Forensic science students are not allowed for the competition.
- Each team will comprise of two members only.
- There is no restriction to the number of teams that may participate from the same institution.
- Individuals who attend only the workshop may do so by registering themselves individually.

MODE OF EVENT : OFFLINE

RULES AND REGULATIONS OF THE COMPETITION

- On the day of the competition, the participants will be given a basic orientation of the competition, an idea of what will be expected in the investigation, the report and analysis.
- Participants will then be briefed about the background of the crime scene set up and would be given the facts of the case.
- Participants shall be provided with the required stationeries and will be taken to the crime scene that will be open to observation for 15 minutes only. The participants are then required to observe, find evidence, clues, ask for reports, make notes and sketches.
- After observation, 30 minutes shall be provided to prepare a report.

The report has to include:

- 1. Background of the crime
- 2. A brief note, sketch and photographs of the crime scene
- 3. List of evidences found
- 4. Types of evidences as per the law & relevance of the evidences in the court of law
- 5. Hypothesis of suspects
- 6. Reasoning behind such a hypothesis.
- Participants shall not be allowed to touch, alter or disturb the crime scene.
- The evidence, as the participants find, may be marked by the volunteers and the required analysis reports or further details will be provided by them.
- Participants will be provided with a device for the purpose of capturing images. Usage of any other own devices shall be a ground for disqualification of the teams.
- The teams shall provide a hypothesis as to the events of crime through the investigation of the crime scene and analyzing the evidence.
- The teams will be required to present the written report. The presentation shall include the legal aspects of the case encompassing the evidentiary value of the marked evidences and the other related laws of the given case.
- Any further instructions regarding the event progression will be provided on the day of the event
- Results will be declared after evaluation of the reports in the valedictory session

THE LANGUAGE OF THE EVENT SHALL BE ENGLISH.


