To encourage sportsmanship and healthy competitions among the colleges involved. To organize Inter law collegiate competition / tournaments in the recognized games and sports, towards selection of University Teams. To raise the general standards of sports and games towards achievement in Inter-University / National / Inter-National tournaments. To organize the National Sports Organisation programme for the total personality development of all students in order to serve the community towards its advancement. To encourage such other activities which may be conducive to the aims and objectives of TNDALU Department of Physical Education Sports.

## Conduct of Sports & Games:

The various Sports and Games to organize Inter law collegiate competition Organizing Secretary (Physical Director) and Coordinator (Principal) responsible for the sports activities of the Inter law collegiate competition.

## **University Teams:**

The followed by sports and Games inter law collegiate tournaments the University team selection committee will select the university teams based on the performance of players in the inter law collegiate basis tournaments. The selected university tames will participate in coaching camps prior their participation in inter-University tournaments.

#### **Paralympic Sports Meet :**

To take care of the physically challenged students of The Tamil Nadu Dr.Ambedkar Law University who have interest in sports and games, special tournaments are organized once in a year, State level tournaments, in athletics and other games, depending on the entries received.

#### Annual Sports Day :

Campus intramural activities will commence from February 1st week every year. Students are divided into different houses. Activities including all major games will be organized in the evenings and on holidays. Track and field events will be conducted on the Sports Day which takes place usually during the month of March. Sports activities for staff will also be conducted on the Sports day.

The Annual Sports day Function to honour the outstanding sports persons best performing of the achievements in State level Inter law collegiate competition Inter-University / National / Inter-National tournaments.

#### **National Sports Organization**

Tamil Nadu Dr.Ambedkar Law University strives constantly to improve personality development of all sportspersons so that they can serve the community for its advancement. In this direction, as part of the AIU Sports Regulations 2012, all the Undergraduate students should enroll on admission to one of the character development programmes, namely National Cadet Corps (N.C.C.), National Social Service (N.S.S.) and National Sports Organization (N.S.O.) under the personality Character Development Programme. On assessment, it is found that these activities have brought discernible change in the attitude of students not only towards their fellow but also towards values of life.

#### Activities of N.S.O. Students

The N.S.O Programme is divided into two parts:

#### • Regular Activities

(Regular Sports Classes are conducted in the evening on all working days between 4.00 p.m. to 6.00 p.m. A Comprehensive sports schedule is in practice, which includes fitness, training, coaching in Sports & Games. It is mandatory for all the NSO students to have at least 80 hours of attendance to enroll themselves in the NSO camp which will be conducted at the end of the academic year.)

#### Residential Camp

The camp is conducted for all NSO students for about ten days, during which the students are made to undergo training in specific sports and games. Activities such as Yoga, First Aid, Swimming are also given due importance. Inter-group competitions are also held during the camp to inculcate the spirit of Sportsmanship. The camp programme is generally organized during 3rd and 4th week of May and June month of every year. The coaches/ Experts are deputed from Sports Authority of India/SDAT and reputed institutions.)

#### **Nature of Sports Activities**

- 1. The School of Excellence in Law Students is divided into Eight Teams (Both Men & Women).
- 2. Total Number of Games and Sports organised are 15 events..
- 3. Competitions are conducted on Inter Law collegiate Sports Meet and Law Schools Sports Meet, Intramurals Sports Meet and Open Tournament.
- 4. Annually nearly 600 Students participate and acquire competitive experience.
- 5. University Players are selected based on their performance in the Inter Law Collegiate Sports Meet.
- 6. Summer Coaching Camps and Sports Day Function are organised annually during the month of March and that of April.
- 7. Awareness Sports Meet and All India Inter University Sports/Games Competitions are organized annually.
- Annual selections are conducted to prepare the School of Excellence in Law Teams (15 disciplines), for participation in the Inter-University Competition Organized by Association of Indian University.

9. To Organize Tamil Nadu Dr.Ambedkar Law University Teaching Staff and Administrative Staff Games and Sports Meet (10 disciplines).

All the above events are designed to effectively develop sports skills and inculcate the ethics of Character building and that of the spirit of friendship and competitiveness.

#### WORKSHOPS AND SEMINARS ON YOGA

To create awareness on the importance of Yoga for healthy wellbeing, sports TNDALU is planning to conduct workshops, seminar along with practice sessions on Yoga on monthly basis.

## AEROBICS CLASSES FOR WOMEN

To enhance the physical fitness in girl students and women, aerobic and zumba classes will be started. Forty five minutes of workout will gradually improve the motor fitness.

## **INVITATION MATCHES WITH NEARBY CLUBS**

Invitation matches in Cricket, Football, Badminton and basket ball are planned to be conducted to enhance the sports skills among the SOEL students. The clubs and teams from nearby colleges will be invited to participate in the matches. These kinds of activities are useful to improvement of skills and for getting match experience.


## **INTRAMURAL COMPETITIONS DURING THE ACADEMIC YEAR**





In addition to her involvement with the SOEL MUN, Harsha has actively participated in various committees both within and outside the college.



# INTRA UNIVERSITY MOOT COURT COMPETITION

9th August, 2023 to 12th August, 2023

### AIM AND PURPOSE:

The Intra University Intellectual Property Law Moot Court Competition, 2023 has been organised with the aim to inculcate interest in Intellectual Property Law and understand the various issues concerning the same. Participation was strictly restricted to bona fide law students enrolled in the three-year or five-year integrated LL.B. course of the School of Excellence in Law, The Tamil Nadu Dr. Ambedkar Law University. The Competition was set to take place in the School of Excellence in Law, The Tamil Nadu Dr. Ambedkar Law University premises (Perungudi Campus).

The Intra University Intellectual Property Law Moot Court Competition, 2023, was an intellectually stimulating and academically enriching event. Organized with the aim of nurturing an interest in Intellectual Property Law among law students, the competition provided a platform for participants to showcase their legal skills and engage in rigorous legal discourse.

# **REGISTRATIONS:**

# **PRELIMINARY ROUNDS:**

On August 10, 2023, the Preliminary Rounds commenced, providing participants with the opportunity to present their arguments and showcase their understanding of Intellectual Property Law.

# **RESEARCHER TEST:**

The Researcher Test, held on August 9, 2023, challenged participants with 25 objective-type questions and 5 subjective questions, further testing their knowledge and analytical skills.

# PRO BONO ENVIRO NATIONAL MOOT COURT COMPETITION

# ABOUT THE PRO BONO ENVIRO MOOT COMPETITON:

The Moot Court Association [MCA] of the School of Excellence in Law, Chennai was established in the year 2008 with the view to promote oral advocacy skills and legal writing techniques. The foremost endeavor of the MCA is to develop and encourage mooting. Our flagship Competition, the Pro Bono Enviro National Moot Court Competition conducted annually since 2007 in collaboration with the Tamil Nadu Pollution Control Board, is the first Competition in the country to address environmental issues. This moot encourages students to expand their awareness of environmental concerns in the present world. The 17<sup>th</sup> Pro Bono Enviro National Moot Court Competition witnessed a total registration of 38 teams of various universities and colleges, more than 110 students took part in the competition.

## **RESEARCHER'S TEST: (23.09.2023)**

The MCA SOEL conducts a unique way of conducting Researcher' Interview by making participants questioned by a Judge in a one-on-one manner. This interview was conducted via the "Google Meet" application and the researchers were questioned by the judging panel to test their knowledge on the given facts and laws revolving around it.

### PRELIMINARY ROUNDS AND OCTA FINALS:

The Preliminary rounds were conducted in online mood via the "Google Meet" application on 24.09.2023. Whatsapp groups were created by the ushers to send communications, instructions and to guide the team throughout the competition. There were 38 teams participating against each other, out of which the top 16 teams from the Preliminary Rounds advanced to the Octafinals. The qualification of the top 16 teams were based on aggregate scores of the judging panel and in the event of tie, the memorandum score of the teams were considered.

The Octa finals were conducted in offline mode, where the top 16 qualifying teams had to come in physical mode on 14.10.2023. They were requested to avail the accommodation provided and send the travel details. The qualification of teams to the Quarter-finals was on a knock-out basis and the memorandum scores were not considered in the advanced rounds.

#### **QUARTERFINALS**:

The Quarter Finals were conducted in offline mode on 14.10.2023 for the top 8 qualifying teams from the Octa finals. The top 8 teams advancing to the Quarter Finals were selected on a knock-out basis.

The teams that advanced to this round were Danube, Irrawady, Tocantius, Yellow, Orinoco, Chulym, Indus, and Aldan. They were from Sastra Deemed University, Tamil Nadu National Law University, Saveetha School of Law-Chennai, Mar Gregorios College of Law-Trivandrum, Symbiosis Law School-Noida, Alliance University-Bangalore, National University of Advanced Legal Studies-Kochi and Tamil Nadu Dr. Ambedkar Law University respectively. The top 4 teams of the quarter-final rounds were selected for the semi-finals on a knock-out basis.

## **SEMI-FINALS:**

The Semi-Finals were conducted in offline mode on 15.10.2023 for the top 4 qualifying teams from the Quarter Finals. The top 4 teams advancing from the Quarter Finals to the Semi-Finals were selected on a knock-out basis. The teams that advanced to the Semi-finals were Orinocco, Irrawaddy, Yellow, and Aldan. They were from Symbiosis Law School-Noida, Tamil Nadu National Law University, Mar Gregorios College of Law-Trivandrum, and

Tamil Nadu Dr. Ambedkar Law University respectively. The top 2 teams of the Semi-Final rounds advanced to the Finals on a knock-out basis.

#### FINALS:

The Finals were conducted in offline mode on 15.10.2023 for the top 2 qualifying teams from the Semi-Finals. The much-awaited Final Rounds of the 17<sup>th</sup> Pro Bono Enviro National Moot Court Competition, 2023 was conducted between Government law college Salem and symbiosis law school Noida. The Final round was judged by an esteemed five judges panel of Hon'ble Justice and Respected Advocates. The teams witnessed an eminent judging panel comprising Hon'ble Justice Mr. Seshayee, Senior Advocate Mr. Raghavachari, Advocate Mr. Vikram Raman, Advocate Mr. Minnah Joshi, and Advocate Mr. Sai Sathya Jith. The top 2 teams from the Semi-Finals advancing to the Finals qualified on a knock-out basis.



#### **ABOUT THE FRESHER'S MOOT:**

Moot court is a primary law school activity, to indulge in, which is the dream of every law student. A moot court is a "mock court" where a hypothetical case is argued by law students in front of a panel of judges. Mooting is a specialised application of the art of persuasive advocacy. Mooting not only helps the students to improve their research and speaking skills, but also enables them to appreciate the law by applying it to the facts of the case. The fresher's Moot Court Competition was a simulation of the actual Moot Court Competition. The primary difference between Freshers Moot and an actual moot is that every student was required to participate individually by formulating and preparing the memorial and arguments by themselves and deliver the arguments.





# K R RAMAMANI TAXATION NATIONAL MOOT COURT COMPETITION

# **INTRODUCTION:**

The 14th KR Ramamani Memorial National Taxation Moot Court Competition, 2024 was organized by the Moot Court Association, School of Excellence in Law, Tamil Nadu Dr. Ambedkar Law University in association with Subbaraya Aiyar, Padmanabhan and Ramamani (S.A.P.R.) Advocates. It was conducted in Hybrid mode on the 9th and 10th of February and 10th of March, 2024.

# **REGISTRATIONS:**

The registration period for the competition was open from December 25th, 2023 to January 14th, 2024. The competition garnered interest from various regions across the country, with a total of 31 teams that registered from various locations across the country. Teams hailed from several regions all the way from New Delhi in the North to Villupuram in the South. We were excited to see such a diverse range of teams apply from across the nation and we anticipated a strong competition with many talented teams participating.

## **ROUNDS:**

The competition was conducted in Hybrid mode, with the Preliminary and Quarter-finals rounds virtually and the Semi-Finals and Finals in offline mode in the Taramani Campus of School of Excellence in Law.

#### **1. Preliminary Rounds:**

# PR VSS RESEARCH PAPER COMPETITION


# **INTRODUCTION:**



## **DAY 1- 19<sup>TH</sup> MARCH, 2024**

The first day of the program commenced at 10:00 AM with a welcome address, followed by a series of lectures delivered by the esteemed associates of KFCRI. Adv. Gopika Shri S, Adv. Soundarya G, and

Adv. Shakthi Priya K and Adv. Gopika Shri S shared their valuable insights on various aspects of ADR. The sessions covered topics ranging from the basics of ADR to its application in contemporary legal scenarios.

Their speeches were concluded with an interactive Q&A session, wrapping up at 12:00 PM. Subsequently, to have an interactive demonstrative session with the participants, the members of the Moot Court Association conducted a demo mediation session for the better understanding of the participants. Day 1 of the orientation was concluded with a vote of thanks at 12:30 PM.

#### DAY 2- 20<sup>TH</sup> MARCH, 2024

The 2<sup>nd</sup> day was marked by a series of comprehensive demonstrations aimed at encouraging student participation in the upcoming ADR events at Aazhi. The members of the MCA meticulously conducted demonstrations for the following competitions: **Client-counselling:** Participants were shown effective techniques for understanding and addressing client concerns in a simulated legal consultation environment.

**Negotiation:** Students were guided through the art of negotiation, learning to find mutually beneficial solutions in adversarial situations.

**Mediation:** The demonstration highlighted the role of a mediator in facilitating dispute resolution between conflicting parties.

**Arbitration:** Attendees received insights on the arbitration proceeding, gaining insights into the formal process of adjudicating disputes.

In addition to the practical demonstrations, the MCA provided a detailed explanation of the procedures for the ADR events to be held at Aazhi. This session was particularly beneficial in addressing any uncertainties and ensuring that all attendees were well-informed and prepared for the competitions.

## **FEEDBACK:**

The orientation on Alternative Dispute Resolution (ADR) was conducted with the aim of equipping participants with essential conflict resolution skills. Feedback collected post-event indicates a highly positive reception, with participants reporting significant learning and direct application of ADR principles during the competition.

**Overall experience:** Participants expressed a high level of satisfaction with the ADR orientation, noting the interactive and informative nature of the sessions.

**Knowledge gained:** There was a unanimous agreement on the substantial learning achieved, particularly in the areas of negotiation, mediation, and arbitration.

**Skills application:** During the competition, participants found themselves well-prepared to handle disputes and negotiations, attributing their success to the ADR techniques learned.

# **ENGLISH MOOT COURT COMPETITION**

### **INTRODUCTION**

The Aazhi Law Fest – English Moot Court Competition, 2024 was organized by the Moot Court Association, School of Excellence in Law, Chennai in collaboration with the Department of Constitutional Law and Human Right, School of Excellence in Law, Chennai. It was conducted on-site from the 4<sup>th</sup> of April, 2024 to the 7<sup>th</sup> of April, 2024.

### THEME

The moot proposition revolved around the theme of election and constitutional law and was drafted by Assistant Professor Karthik Shiva B. under the guidance of Prof. Dr. R. Srinivasan. It drew inspiration from occurrences preceding the general elections, 2024 with its main focus on a fictional amendment to the Constitution of India, 1950, Representation of the People Act, 1950, Representation of the People Act, 1950 and allied Rules.

Participants argued on the feasibility, constitutional validity and security concerns raised over a simultaneous electoral voting system

as well as a fully remote smart-phone enabled voting mechanism. Given their fictional nature, these amendments provided participants with a intriguing experience and inspired them to reach out to their limits of creativity and innovative capacities. In the spirit of multilateralism and global harmony, team-codes that were allotted for this competition comprised of cities from across the world.

### REGISTRATIONS

Over a period of 5 weeks commencing on the 26<sup>th</sup> of February, 2024, this moot court competition amassed 26 registrations from undergraduate students at School of Excellence in Law, Chennai. This competition united avid mooters from all streams of law and across all years of study at the university, making it a heavily competitive showdown of eloquence, knowledge and advocacy.

#### ROUNDS

The competition was conducted on-site, i.e., offline at the Taramani Campus of School of Excellence in Law, Chennai. Participants were required to submit their memorials online for evaluation as well as produce hard-copies of such written submissions for the perusal of the judges adjudicating their performance at the oral rounds of the competition.

### **Preliminary Rounds**

Two preliminary rounds were organized through four-sessions, i.e., each preliminary round was conducted over the course of 2 sessions on the 5<sup>th</sup> of February, 2024. These rounds were adjudicated by students pursuing L.L.M. at School of Excellence in Law, Chennai and advocates practicing before the Madras High Court. In total, there were 32 judges for the preliminary rounds, all of whom were seasoned mooters during their time as under-graduate students of law. All 26 teams argued twice, i.e., once on behalf of the writ petitioners and once on behalf of the respondents to the moot proposition before benches consisting of the above-mentioned evaluators, with each team given a total of 20 minutes per round to put forth their submissions. This included stimulating questions from the judges, followed by intense rebuttal sessions.

With the objective if kindling the spirit of mooting among students of the university, the preliminary rounds were conducted in their classrooms for them to witness and observe the occurrence of an actual moot court competition, and draw inspiration therefrom.

# **TAMIL MOOT COURT COMPETITION**

#### **ABOUT THE COMPETITION**

The Moot Court Association of School of Excellence in Law, Chennai organised a Tamil Language Moot Court Competition as a part of its intra-university law fest, event Aazhi 2024 – an Odyssey through Legal Currents. The event saw registration of 21 intra-university teams, witnessing enthusiastic participation from more than 60 students from all years of 5 Years and 3 Years LL.B. Courses. The Moot proposition dealt with one of the most contemporary issues in the subject of Labour Law, i.e., the status of gig workers under Indian labour law. The Problem was drafted by Mr. Yuvaraj, an LL.M. student of School of Excellence in Law, under the guidance of Prof. (Dr.) J. Mahalakshmi, Head of Department of Labour Law and Administration.

#### THE MOOT PROBLEM

In the vibrant country of AIDIN, the people embraced a constitution embodying values of justice, equality, liberty, and fraternity. Amidst a bustling economy with millions toiling in the organized and unorganized sectors, the winds of Liberalization, Privatization, and Globalization in 1991 brought both prosperity and challenges. Multinational companies and foreign investments fuelled growth, yet the rise of contract employments cast a shadow on labour rights, leaving many in precarious positions.

Enter Harry and Hermoine, dedicated drivers at Road Rocker for two decades, whose lives took a drastic turn during the COVID-19 crisis. Abruptly terminated without terminal benefits, they embarked on a legal battle seeking justice. Their journey led them through the corridors of the Labour Court of Sardam, the High Court, and the Division Bench, all echoing the same verdict - no clear employeremployee relationship existed. Undeterred, they pinned their hopes on the Supreme Court of AIDIN, where their plea awaited a fair hearing.

Amidst this turmoil, the intricate web of agreements between drivers and Road Rocker BV unfolded, revealing the complexities of modernday transportation services. From fare calculations to service fees, the fine print of these contracts added layers to the drivers' quest for recognition and rights. As the wheels of justice turned, the fate of Harry, Hermoine, and countless others in the labor force hung in the balance, symbolizing a larger struggle for dignity and fairness in the evolving landscape of work and technology in AIDIN.

### **COMPETITION ROUNDS:**

#### **RESEARCHERS' TEST**

The Researchers' Test was conducted successfully in online on 3<sup>rd</sup> April 2024, where participants were asked to fill g-form containing a set of 25 Multiple Choice Questions with scoring consisting of negative points. Team Thirukural topped the test, followed by Team Nedunalvaadai.

#### **PRELIMINARY ROUNDS**

The Preliminary Rounds happened in the School of Excellence in Law Campus situated in Taramani on April 5, 2024, with 14 participating teams before 7 Court Halls, each containing two judges. The Judges were students of LLM. (Labour Law) Department, handpicked by Prof. (Dr.) J. Mahalakshmi (Head of Department of Labour and Administration), who volunteered excitedly for the task. There were around 20 judges for two sets of Preliminary Rounds, wherein each participant argued both Petitioner and Respondent side. These judges also scored the Memorials of the participants simultaneously. Among the 14-participating teams, 8 teams were chose to move to the next round, on the basis of highest sum total of scores gained by both Speakers in each Preliminary Round.

#### QUARTER FINAL ROUND

The quarter final round, judged by experienced Law Professors across Universities in Chennai, was conducted on 5<sup>th</sup> of April 2024 in the morning session. The top 8 qualified teams consisting of Team Thirumurugatruppadai, Maduraikanji, Silapathigaram, Seevagasinthamani, Thirukkural, Aathichudi, Purananuru and Mudhumozhikanji, performed remarkably well, which left judges to make tight decisions on who will qualify to the next rounds. The Quarter final round was judged by Professor G.V.Vidhusha, Advocate Idhaya Mary, Professor Durga Devi, Professor Sathish, Professor Marishwari, Professor R.Revathy, Professor Sapna and Professor Pourna Devi.

#### **SEMI FINAL ROUND**

The top 4 who successfully survived the knock-out rounds of Quarter-Finals are Team Thirukkural, Thirumurukatruppadai, Aathichudi and Mudhumozhikanji. The semi-final round was held on the afternoon session of 5<sup>th</sup> of April 2024. Court Hall 1 which face-off Team Thirukural witnessed between and Thirumurukatruppadai was judged by Advocate Arunachalam and Advocate Ilango, in the gracious presence of Advocate Raman, Secretary of the Labour Law Advocate Association, Chennai. The Judges chose to qualify Team Thirukural, after an electrifying round which gave sparks of intellectual curiosity with respect to the contemporary issue. In the feedback session, the judges skilfully explained the art of legal reasoning as well as advocacy, enlightening the students about the requirements for successful legal career, which also served as a fruitful takeaway after a day of competitive rounds. Court Hall 2 of the semi-final rounds was judged by, Advocate Michael Amalraj and Advocate Ravi, each boasting over 30 years of experience in practicing labour law before various labour tribunals and High Courts. Team Aathichodi qualified from Court Hall 2 in a very thin margin.

#### FINAL ROUND

The final round was conducted on 6<sup>th</sup> of April 2024 in the morning session, which happened between Team Aathichudi and Team Thirukkural. The Rounds started with the arrival of judges and

judges' briefing session held by Ms. Sushmitha Senthilkumar, who explained the intricacy of the moot proposition and its legal conundrums. It was judged by Advocate Selvaraj who have more than 30 years of experience in Labour law, Professor Balamurugan (Head of Department of Taxation, SOEL) and Professor Uma Maheshwari (Director-Internship and Associate **Professor**, Department of Labour Law and Administration, SOEL). The Participants showcased their talents for legal arguments before the judges who weighed all arguments carefully and closely questioned the Speakers with respect to legal reasoning of their views. In the end, the Judges gave positive feedback towards the participants. After scoring, Prof. (Dr.) V. Balaji (DEAN) and Prof. (Dr.) P. Brindha (Faculty Co-ordinator of Moot Court Association) felicitated all the judges with a small memento, as a token of gratitude from MCA.

#### VALEDICTORY

# **TRIAL ADVOCACY**

The School of Excellence in Law, organized a Law Fest (AAZHI), whereby it provided the students a variety of opportunity to showcase their legal knowledge and skills. The Law Fest proved to be a wonderful platform for the students to hone their practical skills and prepare them for a successful legal career.

One of the main events of the Law Fest was the Trial Advocacy Competition. The objective of conducting the Trial Advocacy competition was to nurture and create opportunities for development of the skills in litigation, evidence establishment and examination in the Trial Courts.

The Aazhi Trial Advocacy Competition, 2024 was held from 4<sup>th</sup> April 2024 to 7<sup>th</sup> April 2024. It was held offline at The School of Excellence in Law, The Tamil Nadu Dr. Ambedkar Law University. The Competition was open for all students who were pursuing a threeyear or five-year Law Degree Course in School of Excellence in Law. Initially the number of teams participating in the Trial Advocacy competition was restricted to 24 teams on a first come first serve basis. But owing to the overwhelming response from the students of the School of Excellence in law, and the multiple requests made by them, all the 36 teams which had registered for the Trial Advocacy competition were allowed to participate.

The Moot Court Association of the School of Excellence in Law also conducted an orientation programme for the Trial Advocacy competition, to educate and provide an overview to the participants on how the trial advocacy competition would be conducted. This orientation turned out to be a huge success, as majority of the participants had not attended any trial competitions prior to the Law Fest and had no idea on how the competition would be conducted.

#### **Competition Format:**

The Trial Advocacy competition was conducted in two phases. The first phase was the procedure test and the second phase was the oral rounds.

## **Procedure Test**

The procedure test was conducted on 4<sup>th</sup> April 2024, via online. This test was taken up by the researchers of all the participating teams. It took place via G-Meet, in a proctored session, where an organizing committee member was supervising the procedure test to prevent any kind of malpractices. The test was based on the procedural and evidentiary aspects of a Criminal Trial and the application of the penal provisions to the given Trial Proposition.

#### **Oral Rounds**

There were four oral rounds conducted for this competition,

- 1. Preliminary rounds
- 2. Quarter final rounds
- 3. Semi-final rounds
- 4. Final round

In the Preliminary rounds, each team argued, once on behalf of the prosecution and once on behalf of the defence. The aggregate of both these rounds for each team was used for ranking the teams and the teams that made it to the top 8 moved on to the Quarter final rounds. The preliminary rounds were judged by the students pursuing LLM in the School of Excellence in Law.

In the Quarter final rounds which was conducted on 6<sup>th</sup> April 2024, each team presented their case on behalf of either the prosecution or the defence. Whether the teams represented the prosecution or defence was decided by a draw of lots. The team that secured a win against the opposition team in each Quarter Final Round, in a respective court hall, qualified for the Semi-Final Rounds which was also conducted on the 6<sup>th</sup> April 2024. The Semi-final rounds were judged by a division bench. In Court Hall 1, we had Adv. Ashwin and Adv. Hari as the judges. In Court Hall 2, we had Prof. Dr. D. Kannan and Prof. Dr. Vijayalakshmi as the judges. For both the Quarter finals and Semi-finals, the teams were provided with witnesses, who were student volunteers from the first year. The teams had to train the witnesses within 45 mins before the oral rounds beagn.

The team that secured a win against the opposition team in each Semi-Final Rounds, qualified for the Final round of the Trial Advocacy Competition which was conducted on the 7<sup>th</sup> April 2024. For the final round, members from the organizing committee played the role witnesses. The final round was judged by a full bench, consisting of an esteemed panel of judges, Honourable Justice Lingeshwaran, Additional Judge at the Sessions court; Dr. S. Rajalakshmi, Associate Professor and Head of Department of Criminal Law and Criminal Justice Administration in School of Excellence in Law; and Adv. Pratap, one of the founding members of the Moot court Association of School of Excellence in Law, currently practicing at the Public Prosecutors office.

#### Award and Valedictory:

The team that had scored the highest, aggregate of both the individual scores of the speakers, in the final round, the team consisting of Dhaatshayini M, Aruna Shree B and Gajendra Muthukannan, was crowned the winners of the Aazhi Trial Advocacy Competition 2024.

The team consisting of Harsha Janardhanan, Rakshitha S.P, Lakshmi V and Naveen Kumar, were the runners up of the Trial Advocacy competition.

And the team consisting of Shakti P, Thanush Trivikram, Shivashankar and Sonali Sharma, were the 2<sup>nd</sup> runners up of the competition.

The Best Researcher award was given to the researcher who obtained the highest score in the Procedure test that was conducted online.

The Best Chief-examination award was granted to Harsha Janardhanan.

The Best Cross-Examination award was granted to Shobini D.

The Best Witness, from among the student volunteers was given to Manirethinam.

The Spirit of the Competition award was given to Ektha Vivekanandan.

The Hon'ble Mention was given to Kalairasi L.

All the awardees were awarded by our Honourable Vice-Chancellor,

Col. Prof. (Dr) N. S. Santhosh Kumar sir during the valedictory which was held on 7<sup>th</sup> April 2024.
