*The Vice-Chancellor welcomed all the Members for the 184<sup>th</sup> Meeting of the Syndicate held on 30.06.2023. Before briefing the Agenda, the Vice-Chancellor and the Chairman of the Syndicate presented the following before the August Body:-*

- *The University was nominated as the "Best State University (Law)" by the FICCI and The New Indian Express and the award was conferred by the Hon'ble Minister Thiru.T.Mano Thangaraj, Hon'ble Minister for Milk & Dairy Development, Government of Tamil Nadu on 21<sup>st</sup> June, 2023 at Hotel ITC Chola Grand, Chennai.*
- *The University issued application between 15.05.2023 and 10.06.2023 for admission into 5 year Integrated (Hons.) Degree Courses offered in the School of Excellence in Law and 5 year B.A.LL.B. Degree Courses offered in the 23 affiliated law colleges. The first phase of counselling was held on 21<sup>st</sup> and 22<sup>nd</sup> June for the (Hons.) Degree Courses and 22<sup>nd</sup> & 23<sup>rd</sup> for the affiliated law colleges. Instruction classes are started from 26.06.2023. For the first time, the University completed its first phase of counselling in a very short span of 10 days.*

*The Syndicate appreciated the efforts put in by the University towards completion of first phase of counselling within 10 days.*

- *The Vice-Chancellor reported that our esteemed Syndicate Member and the Senior Advocate Thiru. E. Om Prakash came forward philanthropically to sponsor a sum of Rs.1,80,007/- (Rupees One Lakh Eighty Thousand and Seven only) to pay the fee due of Ms. B. Pritha Lakshmi, IV year B.Com.LL.B. (Hons.) Degree Course and D/o of one of our staff member.*
- *The Vice-Chancellor also added that Thiru. E. Om Prakash, our esteemed Syndicate Member also contributing his efforts whole-heartedly to suggest and guide our University as Chairman/Member in the following Committees, viz., AIR, Conduct of Entrance Examinations for admission into LL.M. Degree Course and Grievance Redressal Committee for Teaching and Administrative Staff Members of the University.*

- *The Vice-Chancellor expressed his gratitude to Thiru. E.Om Prakash for volunteering his helping hands financially to the needy and in general shouldering the responsibilities of the University by offering his intellectual contribution for the development and smooth functioning of the University. Ramsridhar for selection and appointment of Assistant Professors on regular basis and also noted that the matter is pending till the date of this meeting.

Subsequently, the Syndicate unanimously RESOLVED to ratify the

renewal contract of 23 Assistant Professors in Law and Inter-Disciplinary Studies working in the School of Excellence in Law, TNDALU for another period of three months commenced from 02.06.2023 to 01.09.2023 or appointment of regular faculties as against the notification published on 18.03.2023, whichever is earlier.

**To consider the request for waiver of penalty amount due from Ms.B.Pritha Lakshme (Reg. No.HB20102) studying in the IV year of B.Com.LL.B (Hons.) and Ms.S. Kowsalya (Reg.No. HD20061) of B.C.A.LL.B(Hons.) degree programme in the School of Excellence in Law.**

The Syndicate NOTED the sponsorship made by our esteemed Syndicate Member Thiru. E. Om Prakash, Senior Advocate, to remit the fee due in respect of Ms. B. Pritha Lakshme, Reg. No. HB20102, presently studying in IV B.Com.LL.B.(Hons.), which was pending from her II Semester to VI Semester and also noted that the penalty fee of Rs. 74,000/- is due from the student for late payment of semester fees.

The Syndicate also NOTED that considering the financial constraint of Ms. S. Kowsalya, Reg.No. HD20061 admitted in the B.C.A.LL.B.(Hons.) Degree Course during the academic year 2020 – 2021 and not able to continue her studies due to fee due from her II Semester to IV Semester and presently caught into break in study for one year, Thiru. K.S. Kandasamy, I.A.S. Managing Director, Tamil Nadu Adi Dravidar Housing & Development Corporation Ltd., (TAHDSCO) has come forward to pay her fee due to enable her to continue her studies. The Syndicate also noted that even if the fee due is borne by him, the penalty fee of Rs. 53,100/- will still be due from the student for late payment of semester fees.

After considering the requisition letter of parent of Ms. B. Pritha Lakshme and the sponsor of Ms. S. Kowsalya and also the additional burden imposed upon the donors to pay the penalty, the Syndicate RESOLVED to waive the penalty for a sum of Rs. 74,000/- in favour of Ms. B. Pritha Lakshme and Rs. 53,100/- in favour of Ms. S. Kowsalya as a one-time measure. This decision is taken considering the financial situation of both the students and this cannot be shown as precedent in future.

*The Syndicate NOTED that one University teaching staff working on contract basis Dr.K.Sangeetha, Assistant Professor has been getting the gross pay of Rs.91,234/- with the entry level scale of Rs.57,700/- at Academic Level 10 w.e.f. 24.09.2019 as per the interim order of the Division Bench of the Hon'ble High Court of Madras in*

W.A.Nos. 3242, 3243, 3245 and 3246 of 2019 on 23.09.2019 and the other contract faculties are getting the consolidated pay for a sum of Rs.60,000/- only.

During the discussion, Hon'ble Thiru. Justice M.S Ramesh, Judge, High Court of Madras and our esteemed member of the Syndicate stated that in the order of the Supreme court in Civil Appeal No.9849 of 2014 of State of Uttar Pradesh and Others Vs. Arvind Kumar Srivastava and others, dated 17.10.2014, it reads as follows:

22. The legal principles which emerge from the reading of the aforesaid judgments, cited both by the appellants as well as the respondents, can be summed up as under.

22.1 The normal rule is that when a particular set of employees is given relief by the court, all other identically situated persons need to be treated alike by extending that benefit. Not doing so would amount to discrimination and would be violation of Article 14 of the Constitution of India. This principle needs to be applied in service matters more emphatically as the service jurisprudence evolved by this Court from time to time postulates that all similarly situated persons should be treated similarly. Therefore, the normal rule would be that merely because other similarly situated persons did not approach the Court earlier, they are not to be treated differently.

Further, the Syndicate noted the UGC Regulations 2018, Clause 13.0 Appointments of Contract Basis "The fixed emoluments paid to such contract teachers should not be less than the monthly gross salary of a regularly appointed Assistant Professor".

Hence, the Syndicate RESOLVED to place the matter of revision of consolidated pay of the contract faculty before the ensuing Meeting of the Finance Committee for consideration.

**Item No:8**

To report the sanctioning of Pension Contribution and Leave Salary Contribution for a sum of Rs.6,45,229/- for the period from 01.06.2022 to 31.03.2023 in respect of Thiru.V.Dharani Babu, Finance Officer of the University.

The Syndicate RESOLVED to sought for Clarification from the Principal Accountant General (A&E), Chennai for remittance of a sum of Rs.1,24,720/- (Rupees One Lakh Twenty Four Thousand Seven Hundred and Twenty only) towards Leave Salary Contribution and Rs.5,20,509/- (Rupees Five Lakh Twenty Thousand Five Hundred and Nine only) towards Pension Contribution, totally for a sum of Rs.6,45,229/- (Rupees Six Lakh Forty Five Thousand Two Hundred and Twenty Nine

- Dr. T.R. Arun, Principal i/c., Government Law College, Namakkal and esteemed Member of the Syndicate raised the issue of mandatory requirement of completion of 3 years after obtaining Ph.D. to become a Guide/Supervisor to the research scholars. He has placed a request before the Syndicate to relax the 3 years' experience referring in Rule 13 Eligibility criteria for Research Guides/Co-Guides which reads as follows:

"A full-time regular Professor/Associate Professor/Assistant Professor in Law/working in any department of this University or in any of the affiliated colleges of this University holding Ph.D Degree in Law, with teaching experience of not less than 3 years and 2 publications in their area of research in reputed/peer - reviewed journals, "UGC Care list, UGC recognized old journals" after obtaining the Ph.D degree in law, shall be recognized as research guide. Apart from the above, the faculty should have presented at least one full paper in an International/National Conference/Workshop/Symposia."

The Syndicate after detailed discussion RESOLVED that the 3 years teaching experience mentioned in rule 13 of the Ph.D research regulations required for Ph.D. guideship can also be 3 years of full-time qualified teaching experience obtained before conferment of Ph.D. Degree from any recognized institution.

The Syndicate RESOLVED to place the relaxation for experience to become a research guide for consideration in the Board of Research Studies and also for approval in the Academic Senate.

- Dr.S. Murugesan, Associate Professor, Government Law College, Trichy requested to organize the cultural Programmes at all affiliated Government Law Colleges and to allot fund from the University as fee collected from the students of Government law Colleges viz. Cultural Meet, Sports, Moot Court etc., to meet out the expenditure relating to the conduct of the above said programme.

The Syndicate noted that 2 applications received by the University in the month of July and September 2023 in continuation of the NOCs issued by the Government of Tamil Nadu, vide (1) G.O(Ms.) 407, Law(LS) Department dated 12.07.2023 in favour of Sri S. Kuppusaamy Memorial Educational Trust, Thiruvannamalai District to establish a Private Self-Financing Law College in the name and style of "SKP Law College" at Chinnakangiyanur Village, Tiruvannamalai District and (2) G.O. (Ms.) No.508, Law (LS) Department dated 12.09.2023 in favour of Thandapani Pillai & Sons Educational and Charitable Trust to establish a Private Self-Financing Law College in the name and style of "Sir Isaac Newton Law College" at Pappakovil, Anthanapettai post, Nagapattinam District.

The Syndicate also noted that the applications submitted by the Trusts will normally be forwarded by the Director of Legal Studies and the same will be considered by the Secretary (Legal Affairs), Government of Tamil Nadu for issue of No Objection Certificate to establish any Private Self-Financing Law College and based up on the same the University will form a Committee to inspect the proposed institution premises and

*In this connection, the Syndicate deliberated on the resolution passed on Item No.15 of the 184<sup>th</sup> Meeting of the Syndicate held on 30.06.2023 constituting a Committee to frame the revised rules and regulations for affiliation and approval of Law Colleges and to stop the processing of applications for affiliation/establishment of new Private Law Colleges till the framing of new revised regulations and pointed out that the members can consider modifications to permit the said 2 applications for which the NOCs were issued by the Government in terms of existing regulations instead of looking for proposed new revised regulations. 



The Syndicate in the similar lines of the resolution passed on 19.12.2023 at the 186<sup>th</sup> Meeting of the Syndicate vide Additional Agenda Item No. 2, RESOLVED to consider the Sweeper-Cum-Sanitary Workers working in the Tamil Nadu Dr. Ambedkar Law University for more than 4 years on daily wage basis to convert in to

consolidated pay, subject to the fulfillment of compliance of the required qualification and submission of certificates as stipulated in Schedule-V appended in the Tamil Nadu Dr. Ambedkar Law University Act, 1996.

The Syndicate also RESOLVED to fix a sum of Rs. 18,000/- per month on par with the remuneration being paid to Office Assistants. Further, the benefitting Sweeper-Cum-Scavengers are required to work on all Saturdays as normal working day and need to work on Sundays, in case of organizing any academic and administrative events in the University. The work attended on Sundays will not be considered for availing Compensatory Holidays at any cause. The University is authorized to terminate any such workers when they found their performance is not satisfactory.







It shall not be cited as a precedent in future.*


