## MEASURES INITIATED BY THE INSTITUTION FOR THE PROMOTION OF GENDER EQUITY

### SAFETY AND SECURITY:

The University has taken commendable steps in securing the safety of the students.

- **Surveillance Systems:** CCTV cameras are installed across the institution to monitor the activities of the students and to prevent potential incidents.
- **Security Personnel:** The Institution has employed well-trained security personnels to monitor the University premise and to respond to any security or other potential threats.
- **Grievance Redressal Mechanism:** The University has constituted Grievance Redressal Committee, to address the issues and complaints of the students on sexual harassment, ragging and other related issues. Anti-sexual harassment Cell has been constituted to prevent sexual harassment and to enquire and take action against such complaints. As per sec 6(2) of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013, an **Internal Complaints Committee (ICC)** was duly formed in the University to look into and adjudicate matters relating to any kind of sexual harassment meted out by girl students or female employees in the Institution.
- Each year, the ICC hosts a unique program session on sexual harassment, during which students are instructed on how to file a complaint and utilize the ICC. The University and its website prominently showcase the information of its members.
- **Anti- Ragging Committee:** Anti-ragging Monitoring Cell has been constituted to create a ragging free environment and to take measures to achieve the same. It takes complaints from students on ragging. The Institution has anti ragging committee and Anti ragging squad members to monitor and take action to provide redressal.



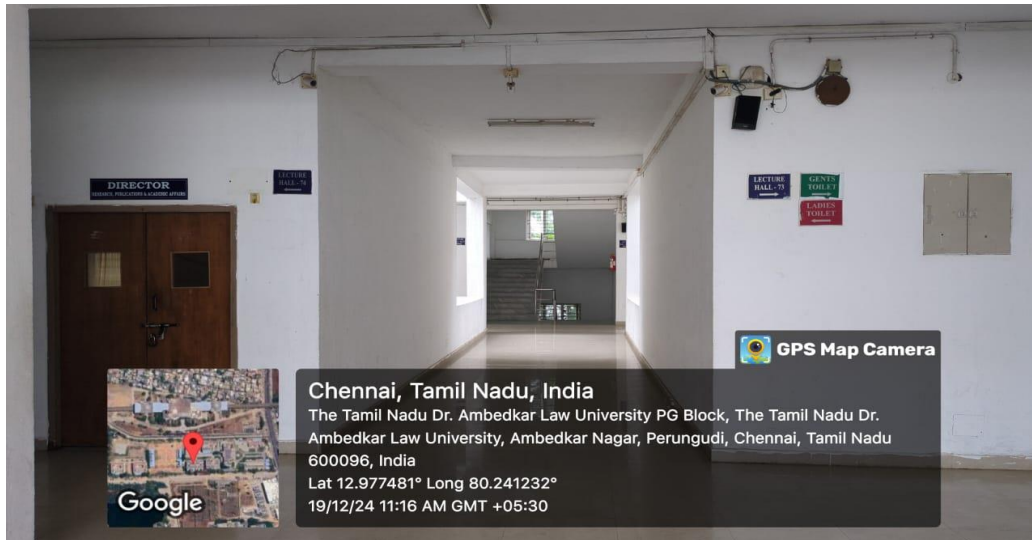

- **Awareness Programmes:** The University organises awareness programme every year on gender sensitisation to promote gender equity.
- **Counselling Cell:** Counselling Cell is constituted to students to address and provide help to various issues like academic stress, mental health concerns, career guidance, interpersonal conflicts etc., that students face during their academic journey.
- **Gate Security:** Two gates lead into the main campus. Members of the committee and gate security can keep an eye on the students. They examine the student's ID cards, dress code, haircuts, and other details in addition to closely observing their manners.

### CCTV CAMERA





CCTV is installed everywhere in the campus except the lavatories to monitor and deter potential threats ensuring safety and security of the students. The University, by providing the administrators and security personnel with real-time monitoring capabilities, CCTV installation has enabled enhanced supervision thereby minimising unwanted incidents. It has become a deterrent tool against misconduct like bullying, vandalism etc.



### **TNDALU COUNSELLING SCHEME**

Women students confront several hurdles and sometimes lack positive relationships with their families and society. So TNDALU provides counselling services depending on the counsellor's report. Counselling that focuses on how to overcome societal and personal difficulties. TNDALU recognises the importance of counselling for female students in navigating their demands and achieving academic success. TNDALU's objective is to promote the complete development of female students.

Counselling is available for free to all female students and staff, providing anonymity in academic and non-academic settings. It makes a significant contribution to promoting psychological characteristics among female students in order to fulfil their academic, personal, and relational goals. Women student mentors are appointed to address issues related to stress, relationships, and family. To support students' mental health, the Women's Care Centre coordinates counselling services within the university.

A professional clinical psychologist is accessible eight hours a week. In addition to regular counselling sessions, she addresses frequent concerns faced by young adults. Counsellors at TNDALU offer individual and group sessions, as well as department-specific informal talks, to address mental health concerns among female students without stigma. TNDALU offers a strong Mentor-Mentee Programme that complements teaching and learning. Each student is assigned a faculty mentor, allowing for individual counselling sessions.

The mentor-mentee ratio is 1 to 65. Mentors assess students' needs and propose formal counselling as necessary. This contributes significantly to confidence and skill development. Aside from professional counselling, different departments and groups at the TNDALU hold counselling workshops for students. Legal experts will discuss sexual harassment using real-life examples. Special lectures cover topics such as gender sensitization. Departments organise career counselling workshops to educate students about options in their profession. Students benefit from opportunities to overcome challenges such as exam anxiety, study conflicts, and life stressors.

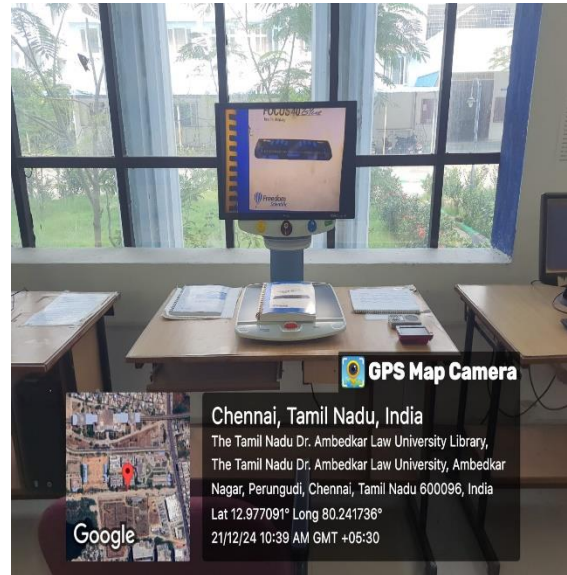
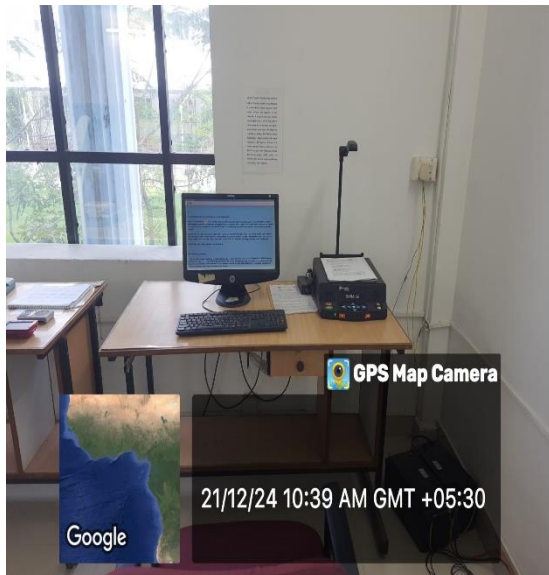
