- Online gateway system should be a single window system with transaction facility
- Fee collection through online mode shall be in safe mode both for the Institution and for the students
- Password provided shall be accessible only for the University and not by the bank or other service providing agencies
- The soft copy of the account statement is required as database containing the details
  of examination fee paid by our students through online mode to the Bank Account
  viz., Student Name, Register Number, Name of the Course, Year of the Course,
  College Centre No., Description of Fee paid, Date and Amount of Fee paid etc., to
  the e-mail ID of the Finance Section of the Tamil Nadu Dr.Ambedkar Law
  University.
