It is informed that, as part of our Hon'ble Vice-Chancellor's initiative for promoting and enhancing the legal education of SOEL, a prestigious STUDENT EXCHANGE PROGRAM is offered to our Third-Year of 5 Year Integrated (Hons.) Law Degree Programmes Students. Already during 09.09.2024 to 14.09.2024 as a policy of Exchange Programme between National Law Schools, 20 students of TNDALU have already visited Gujarat National Law School, Ahmedabad

Next phase of the same, to have an advance exposure, an International University Exchange Programme has been arranged from **06th of April to 14th of April, 2025, at UNIVERSITY KEBANSAAN, MALAYSIA (National University of Malaysia)** as per the MoU with this University and TNDALU. According to the curriculum and pattern of University of Kebansaan and TNDALU, the Registration opens **only for the Third-Year students of 5 Year Integrated (Hons.) Degree Programmes**. Two Faculty members of TNDALU shall be accompanying the students. Interested students are invited to register for the program, subject to the following conditions:

- 1. Total number of Students permitted to attend the Programme – 20 Nos.**
- 2. Dates of the Programme – 06th of April to 14th of April, 2025.**
- 3. Students should bear the Travelling, Accommodation, Food and other Charges for the said programme. TNDALU shall not grant any Financial Assistance in this regard.**
- 4. The program duration will be 7 days, with the total trip lasting approximately 9 days.**
- 5. Valid Passport copy and Parental Consent** must be uploaded in **PDF Format** before Registration.
- 6. Students with any Health Issues are Not Eligible** to apply.
- 7. The host University is expecting students with Good Command of Communication Skill.**
- 8. Preference will be given to students with an Excellent Academic Record.**
- 9. The decision of the Administrative Authorities shall be Final** in the selection process.

Students who meet the eligibility criteria and are interested in this enriching academic experience are encouraged to apply before **5.30pm – 13.02.2025**.
