It is informed that all the students belonging to **SC/ST/SCC** Community who studying in 5 Year Integrated B.A.LL.B.(Hons.), B.Com.LL.B.(Hons.), B.B.A.LL.B.(Hons.), B.C.A.LL.B.(Hons.), 3 Year LL.B.(Hons.) and LL.M. Degree Programmes in the School of Excellence in Law can download the softcopy of the '**Adi - Dravidar and Tribal Welfare Department, Government of Tamil Nadu Scholarship Application Form (Fresh Form or Renewal Form)**' for the Academic Year **2024-2025** from the University Website www.tndalu.ac.in. Duly filled-in Application (Fresh Form or Renewal Form) along with the copy of the following documents must be submitted to the Scholarship Counter **on or before 25.01.2025**.

1. Updated Income Certificate (The income limit for scholarship is Rs.2,50,000/-.
There is no income limit for tuition fee waiver).
2. Income Certificate and Community Certificate (Only accepted as e-certificates).
3. Bank Account Number which in linked with Aadhaar.
4. 10th & 12th Mark Statements.
5. Student Aadhaar Card.
6. Students are required to submit an '**Undertaking**' that -

On receipt of the 'Tuition Fee' Amount received from the Government of Tamil Nadu sanctioned under "SC, SC(A), ST and SCC (Converted Christian from Scheduled Caste) Category" will be returned by me to "The Registrar, Tamil Nadu Dr.Ambedkar Law University, Chennai" by way of Demand Draft, within Seven Days of the receipt of the Tuition Fee Amount.

7. Students are required to submit the '**Demand Draft**' to the respective Course Counter of the Office of the U.G. and P.G. Degree Programmes, without fail.

It is further informed that the SC/ST/SCC Students who were admitted under the 'Categories' of '7.5% Internal Reservation' and 'Physically Challenged Persons' need Not obtain "Application for SC/ST/SCC Scholarship 2024-2025" for availing Scholarship and Tuition Fee Waiver, since the Students are 'Eligible' to avail one benefit only.

1. The Students in receipt of OTP number should immediately inform the office of the UG & PG to confirm their Scholarship Application.
 2. If any of the SC/ST students who do not apply for the Government Scholarship within the specified time limit, they will be responsible for paying the entire Tuition Fee to the University.
