It is informed that the "Instruction Classes" for the Second Year to Final Year of 5 Year Integrated (Hons.) & 3 Year (Hons.) Degree Programmes for the Even Semester will be commenced on 04th December 2025.

Therefore, the students who are pursuing Second Year to Final Year of the 5 Year Integrated B.A.LL.B. (Hons.), B.Com.LL.B. (Hons.), B.B.A.LL.B. (Hons.), B.C.A.LL.B. (Hons.) & 3 Year LL.B. (Hons.) c.	"SCC/SC/ST category"	students	Students admitted under this category and who are eligible for promotion to next higher classes (Even Semester only) are exempted from payment of Tuition Fee. Moreover, students must pay the amount to the educational institution within seven days of it being credited to their account by the Government. (vide Govt. Norms for 3 Year LL.B. (Hons.), U.G. Degree Programmes:-

a.	"Differently Abled category"		Students admitted under this category and who are eligible for promotion for promotion to next higher classes (Even Semester only) are exempted from payment of Tuition Fee and Special Fee.
b.	"SCC/SC/ST category"	students	Students admitted under this category and who are eligible for promotion to next higher classes (Even Semester only) are exempted from payment of Tuition Fee. Moreover, students must pay the amount to the educational institution within seven days of it being credited to their account by the Government. (vide Govt. 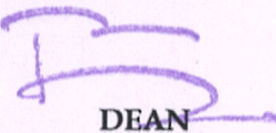
