CIRCULAR

Sub: The Tamil Nadu Dr.Ambedkar Law University - School of Excellence in Law - LL.M. (CBCS) Degree Programme - Students of Second Year for the Academic Year 2026-2027 (2025-2027 Batch) - Remittance of Annual Fee through Online Payment and submit the Receipt to the P.G. Office - Intimation - Reg.

It is hereby informed that all the Second Year Students of the LL.M.(CBCS) Degree Programme, School of Excellence in Law, The Tamil Nadu Dr.Ambedkar Law University, for the Academic Year 2026-2027 (2025-2027 Batch) are required to remit a sum of **Rs.32,000/- (Rupees Thirty Two Thousand Only)** towards the Annual Fee for 2nd year through online **Indian Bank Fee Payment Gateway** available on the University Website (www.tndalu.ac.in) **on or before 31.07.2026** and obtain the 'Receipt' from the office of the Post Graduate Degree Programme on submission of online receipt during office hours on all working days.

It is further informed that:

- a) Pursuant to the Orders of the Government of Tamil Nadu, students belonging to the **Scheduled Castes (SC), Scheduled Tribes (ST), and Scheduled Castes Converted to Christianity (SCC)** are granted exemption from the payment of tuition fees. Accordingly, such students shall remit only a sum of **Rs.12,000/- (Rupees Twelve Thousand only)** towards other fees for the second year.
- b) Students availing themselves of the aforesaid tuition fee exemption are required to submit their application for the **Post-Matric Scholarship** through the SSP Portal compulsorily. Upon receipt of the said scholarship amount from the Government, the tuition fee of **Rs.20,000/- (Rupees Twenty Thousand only)** should be remitted to the University within seven days from the date of receipt.
- I. Students with **benchmark disabilities (Differently Abled Students)** are granted full exemption from the payment of the Annual Fee.

Students are instructed to pay the specified Annual Fee before the stipulated last date as the Payment Gateway will automatically close after the last date.
