Detail Information of State Level Inter Law Collegiate

Athletics Meet (Men & Women)- 2026-27

IMPORTANT INSTRUCTIONS:

Mandatory Documents to be Submitted

1. Every participating college shall submit the following documents for each Athlete:

- i. Original College Identity Card (to be produced for verification during the Athletics Meet.
- ii. Photocopy of the Higher Secondary (+2) Mark Statement and SSLC (10th Standard) Mark Statement or equivalent certificate as proof of age.
- iii. Students admitted undergraduate 3Year LL.B. Programme shall additionally submit a photocopy of their Undergraduate Degree Provisional Certificate.
- iv. Photocopy of Aadhaar Card.
- v. Eligibility Proforma duly filled in with a passport-Size photograph.
- vi. Bonafide Certificate certifying that the student is a bona fide student of the respective college.
- vii. First -Year students submit your admission fee receipt, if your college ID Card has not yet been issued, attach a Bonafide certificate instead.
- viii. Team Registration Form / Detailed Entry Form for the individual events.

2. Eligibility of Age Category:

- i) Minimum :17 years on or before Commencement of the tournament;
- ii) Maximum: Under 25 years as of 1 July of the academic year.

3. Code of Conduct and Disciplinary Action:

- i) All Law College team players shall uphold the dignity and reputation of their College and the University by maintaining proper discipline and refraining from any unethical or inappropriate conduct during travel, accommodation, and participation in the Athletics Meet/Tournaments.
- ii) Any violation of this Code of Conduct or refusal to abide by the decision of the Umpire/Referee shall invite strict disciplinary action. The player(s) or team concerned shall be debarred from participating in all Inter-Law Collegiate Sports and Athletics Meets/Tournaments conducted by the University for a period of three (3) academic years.

4. Identity Verification

All athletes participating in the Track and Field events shall produce their College Identity Cards, duly attested by the Principal/Director of Physical Education/Physical Director, at the time of the competition.

5. Reporting Time

Athletes shall report to the Call Room / Table **30 minutes** before the scheduled commencement of their respective events.

6. Inaugural Ceremony

The Inaugural Ceremony of the Athletics Meet will be held at **8.00 a.m.** All participating colleges are requested to bring their respective **College Flag**. March Past Order of College List is enclosed.

7. Rules of Competition

The Athletics Meet shall be conducted in accordance with the latest Rules of the **Athletics Federation of India (AFI)** as adopted by the **Association of Indian Universities (AIU)**.

8. Team Championships

Separate Championships shall be awarded for **Men** and **Women** Athletics Championship Trophies shall be awarded only to the:

- First Place
- Second Place
- Third Place

9. Athletic Championship – Points System

The Tamil Nadu Dr. Ambedkar Law University shall determine the **Inter-Law Collegiate Athletics Championship** based on the points secured in all events.

The following points system shall be adopted:

Position	Points
First Place	6 Points
Second Place	4 Points
Third Place	2 Points

For Relay Events, the following points shall be awarded:

Position	Points
First Place	7 Points
Second Place	5 Points
Third Place	3 Points

10. Championship

The Overall Championship shall be decided based on the **Medal Tally (Gold, Silver and Bronze Medals)** in accordance with the AIU Rules.

11. Entries per Event

A maximum of **two (2) athletes** from each college shall be permitted to participate in each individual event.

12. Maximum Events per Athlete

An athlete may participate in a maximum of **two (2) individual events only**, excluding relay events, as per AIU Rules.

13. Restriction for Sprint Events

For the **100 m, 200 m and 400 m Track Events (Men & Women)**, only one athlete from each college shall be permitted to participate (either Direct Final or based on timing), as approved in the Physical Directors' Meeting.

14. Individual Championship

The **Best Athlete (Men & Women)** shall be determined based on the **total points secured in any two individual events**, excluding relay events. In the event of a tie, the winner shall be decided based on the **World Athletics (formerly IAAF) Scoring Tables**.

15. Selection for AIU Competitions

Outstanding athletes from the Inter-Law Collegiate Athletics Meet shall be selected for participation in the **Association of Indian Universities (AIU) Inter-University Athletics Championship**, subject to achieving the **Minimum Qualification Standards (MQS)** prescribed by AIU.

16. Chest Numbers

The Organizing Committee shall allot **Chest Numbers** to all participating athletes. College-wise Chest Number details are enclosed.

17. Accommodation

Accommodation will be provided only to eligible participating teams. Details regarding the accommodation venue will be communicated separately.

18. Arrival Formalities

Upon arrival at the accommodation centre, each team shall submit:

- College Identity Cards
- Aadhaar Card Photocopies

The **Director of Physical Education/Physical Director/Team Manager** shall be solely responsible for the conduct and discipline of the team during their stay.

19. Awards

For all events (Men & Women):

- Medals and Certificates shall be awarded to the individual winners.
- Athletics Championship Trophy (Men & Women).
- Best Athlete Award (Men & Women).

20. Protest

The decision of the Referees/Jury shall be **final and binding**. No protest or appeal shall be entertained.

21. Right to Modify Schedule

The Organizing Committee reserves the right to alter the venue, date, time or schedule of any event, if circumstances so warrant.

22. Smoking

Smoking and the consumption of tobacco products are strictly prohibited on the University campus, at the accommodation center, on the sports fields, and at the Jawaharlal Nehru Stadium sports venue. No player or participant shall enter the campus or participate in the event under the influence of alcohol, intoxicants, or drugs. Any violation of these rules will result in immediate suspension from the competition and disciplinary action.

23. Accompanying Persons (Students)

Persons other than the officially entered athletes and approved team officials shall **not be permitted** to stay in the accommodation or enter the competition areas.

24. Sports Uniform

All athletes shall participate only in **proper sports attire/uniform**.

25. Vacating Accommodation

Teams shall vacate the accommodation **immediately after the completion of the Athletics Meet**, and in any case **not later than 8.00 p.m.** on the date notified by the Organizing Committee.

26. Colleges Not Eligible for Accommodation

Accommodation will **not** be provided to the following colleges, as they are situated within the Chennai Zone:

1. Dr. Ambedkar Government Law College, Pattaraiperumpudur
2. Dr. Ambedkar Government Law College, Pudupakkam
3. Government Law College, Chengalpattu

27. Olympic Torchbearer - Eligibility Criteria:

The Student (either Male or Female) will Serve as the Olympic Torchbearer during the inaugural ceremony of the State Level Inter Law Collegiate Athletic Meet for the academic year 2026 - 2027.

The student must satisfy any one of the following eligibility criteria:

- 1] He/ She should Represent TNDALU & All India / South Zone Inter University Athletic Medalist.
- 2] He/ She should be an National Level Athletic Medalist in recognized SDAT Sports Association/ Federation Athletic Meet . (Open tournaments are not eligible)

Note: Director of Physical Education are instructed to Select one student who satisfy the above Criteria & Mention their Name and also their Achievements by enclosing the Certificates for Olympic Torch (Should Submit **before 10.08.2026**)

28. Last Date for Submission

The **last date** for receipt of the Detailed Entry **Forms is 10 August 2026 (Monday)** on or before 5.00 p.m. Late entries will not be entertained.
