



**INSTRUCTIONS TO THE CANDIDATES**

**Candidates are required to read the following Instructions carefully before filling the Exam Application Form**

1. May, 2026 Examinations will be conducted only through **OFFLINE MODE** and there is no change in the Question Paper Pattern of Examinations.
2. Examination Schedule and Time-Table is available in the University website and notice board of the SOEL.
3. Examinations are conducted for the candidates of 5 Year & 3 Year Honours Law Degree Courses as detailed below:

**I. FOR 5 YEAR HONOURS DEGREE COURSES:**

- (i) For the candidates admitted during the academic year 2025 - 2026:
  - The 2<sup>nd</sup> (EVEN) Semester examinations and their arrear examinations shall be conducted.
- (ii) For the candidates admitted to the academic years from 2020 - 2021 to 2024 - 2025 :
  - All current EVEN semester and their arrear examinations shall be conducted.
- (iii) For the candidates admitted to the academic year from 2019 - 2020 to 2020 - 2021:
  - Permitted to write their arrear examinations.
- (iv) For the candidates admitted to the academic year 2018-2019 only
  - Permitted to write their arrear examinations as one time measure
- (v) For the candidates admitted prior to the academic year 2018-2019
  - Not permitted as per UGC guidelines of Uniform span period (N+2)

**II. FOR 3 YEAR LL.B. HONOURS DEGREE COURSE:**

- (i) For the candidates admitted during the academic year 2025 - 2026 (First year students of this academic year) :
    - The 1<sup>st</sup> (ODD) Semester & 2<sup>nd</sup> (EVEN) Semester examinations shall be conducted.
  - (ii) For the candidates admitted to the academic years from 2022 - 2023 to 2024 - 2025 :
    - All current EVEN semester and their arrear examinations shall be conducted.
  - (iii) For the candidates admitted to the academic year from 2021 - 2022 to 2022 - 2023:
    - Permitted to write their arrear examinations.
  - (iv) For the candidates admitted to the academic year 2020 - 2021 only:
    - Permitted to write their arrear examinations as one time measure
  - (v) For the candidates admitted prior to the academic year 2020-2021
    - Not permitted as per UGC guidelines of Uniform span period (N+2)
4. Candidates shall apply for the examination only through **online mode by visiting the University website: [www.tndalu.ac.in](http://www.tndalu.ac.in)** and fill the application form, pay the required fees and submit the exam application form.
  5. Applications submitted through any other mode shall not be accepted.

6. In the online Exam Application form,

1. Candidates are required to fill in the correct details in the application form
2. Candidates are required to upload the Passport size photo with white background of dimension 2 inch x 2 inch (Maximum file size : 1 mb). No selfie photos are accepted.

**Subject Registration:**

1) For currently studying students:

- All the subjects of the current semesters will be registered compulsorily.
- All the arrear subjects of the students whether in Internal/External will also be registered compulsorily.

(2) For course completed students but still having arrears:

- All the arrear subjects of the students whether in Internal/External will be registered compulsorily.

(3) Candidate can download the **subjects registered sheet** for their future reference.

7. Fee details:

- Total Fees to be paid by the candidates will be displayed and the candidate has to remit the same to complete the application.
- Candidates shall pay the required fees through the online payment gateway only.
- The fees once paid will in no circumstances be refunded or held over for the subsequent examinations.

8. **Visually Challenged Candidates** are exempted from payment of examination fees. However they should pay the fees for Statement of marks and application cost.

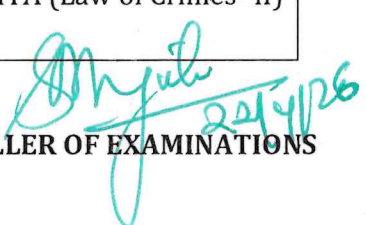
9. **Candidates are required to verify the details before submitting. No further corrections will be allowed.**

**IMPORTANT NOTE**

1. It is informed that the newly introduced Criminal Law Subjects with new syllabus are applicable from the academic year 2024-2025 onwards.
2. Candidates who are having arrears in Criminal Law Subjects (under the old syllabus) viz., The Law of Evidence, Law of Crime (IPC) and The Criminal Procedure Code shall write the examinations under the Old Syllabus.
3. Candidates currently studying/studied, the newly introduced subjects, viz., BHARATIYA SAKSHYA ADHINIYAM (Law of Evidence), BHARATIYA NYAYA SANHITA (Law of Crimes-I) and BHARATIYA NAGARIK SURAKSHA SANHITA (Law of Crimes- II) shall write under the new syllabus.
